Evaluation Comments

Deloitte Consulting LLP

Strengths

Proposal demonstrated firm's knowledge of the total benefits package. Proposal demonstrated firm's domestic and National resources for research and market data. Proposal demonstrated firm's clear understanding of project length. Firm provided a detailed timeline, project approach, and communications plan. Firm proposed a comparison to sister cities and recommended to make changes accordingly. Firm's proposal suggests the use of policy and procedure reviews.

Weaknesses

Contract exceptions. Firm's reference projects were not of similar size, scope, or complexity. Proposal demonstrated firm has limited experience for scope of work services and public sector experience. Proposal demonstrated 3 of 5 proposed team members have limited experience performing scope of work services. Firm failed to include report examples, presentation details for council approval, and in-person reports/presentation. Firm proposed 10 reports for the contract period, which is not acceptable to Metro.

Evergreen Solutions LLC

Strengths

Proposal demonstrated firm's specialization in public sector work.

Weaknesses

Firm's proposal failed to demonstrate firm's capacity to perform scope of work. Proposal was unclear demonstrating work performed with listed clients. Firm's reference projects were not of similar size, scope, or complexity and lacked detail. Firm failed to identify a PM for Metro contract.

Proposal demonstrated firm's limited experience providing scope of work services. Firm's Organizational Chart was unclear. Firm's proposed timeline was not acceptable to Metro, and proposed project approach lacked detail. Proposal failed to demonstrate firm's clear understanding of scope of work.

Gallagher Benefit Services Inc

Strengths

Proposal addressed compression mitigation, and proposed a variation of implementation scenarios. Proposal addressed internal equity. Proposal demonstrated firm's public and private H.R. experience and certifications.

Weaknesses

Contract exceptions. Proposal focused on specialty work, not related to scope of work. Proposal lacked detail demonstrating firm's experience providing scope of work services. Firm's proposed project team was unclear for Metro contract. Proposal was unclear demonstrating team experience and company history. Proposal failed to identify firm's location during study/contract. Firm's reference projects were not of similar size, scope, or complexity and lacked detail. Firm's proposed project approach and communications plan lacked detail. Proposal suggests additional costs for onsite visits, which is not acceptable to Metro. Firm's proposed timeline lacked detail, no actual numbers were proposed. Firm failed to include report examples.

Mercer US LLC

Strengths

Proposal demonstrating firm's 81 years of experience providing scope of work. Proposal demonstrated firm's experience and available resources for research data and market research. Proposal demonstrated firm's experience and knowledge of total compensation, and public sector experience. Firm proposed four presentations to Metro, with two implementation scenarios. Firm proposed mapping each employee to recommended pay plan.

Weaknesses

Contract exceptions. 2 of the 4 reference projects were not of similar size and lacked detail. Proposal was unclear identifying proposed team for Metro and lacked detail demonstrating proposed team collaborations. Firm's proposed project approach, safety plan and communications plan lacked detail. Firm failed to provide a project timeline.

Segal Company (Eastern States) Inc

Strengths

Proposal demonstrated firm's location to be local for duration of study/contract, and sister city experience. Reference projects were of similar size, scope, and complexity. Proposal demonstrated firm's ability to work with population groups, and classes. Firm proposed a point factor system.

Proposal demonstrated firm's experience in public sector work, and understanding of differences in pay plans. Proposal suggests benchmarking tools used becomes property of Metro. Firm provided detailed summary samples.

Weaknesses

Contract exceptions. References lacked dates. Firm's proposed custom survey option lacked detail. Firm's proposed benchmark resources was unclear and lacked detail. Firm's proposed benefits package lacked detail. Proposal focused on private sector work. Proposal was unclear and lacked detail demonstrating research data and market research data. Firm proposed one onsite presentation, which is not acceptable to Metro. Firm proposed extra rates for services, which is not acceptable to Metro.
