**INSTRUCTIONS FOR REGISTRATION AS A STATE PLUMBING CONTRACTOR FOR  
NASHVILLE/DAVIDSON COUNTY, TENNESSEE**

Before completing Steps I-VI, you must first have a State of Tennessee License with the Classification of CMC or CMC-A. If you do not hold either of these classifications, you will need to contact the Department of Commerce and Insurance, Board for Licensing Contractors, 500 James Robertson Parkway, Suite 110, Nashville, Tennessee 37243, Phone (615) 741-8307.

**STEP I**

To apply for Registration as a Nashville and Davidson County State Plumbing Contractor, please complete the "Application For Registration as a State Plumbing Contractor". The applicant who was administered the State of Tennessee examination or proficiency test must complete the form. The only State Plumbing Classifications accepted in Nashville and Davidson County are CMC or CMC-A.

**STEP II**

The sole proprietor, partner or corporate officer must sign the Registration form, verifying all information on the Registration form is true, and attest to the validity of the applicant's signature.

**STEP III**

The Registration form must be notarized by a Notary Public attesting to the validity of the applicant and/or sole proprietor, partner or corporate officer's signature.

**STEP IV**

No Registration will be approved by the Director of Codes Administration until the following documentation is provided. Incomplete Applications for Registrations will not be accepted.

- **Provide a copy** of your State of Tennessee Contractors License
- Affidavit from the State of Tennessee verifying Qualifying Agent for each classification
- Metropolitan Permit Bond - \$40,000 – **Original Bond Required**
- Certificate of Insurance, General Liability, minimum amount \$300,000 *Metro Codes as "certificate holder"*
- Davidson County Business License – 615-862-6050
- Local or Toll Free Telephone Number
- A Check in the amount of \$100.00 for the License Registration Fee, made payable to "*The Metropolitan Government*"
- The Permit Bond, Certificate of Insurance and Metropolitan Business License must be in the name displayed on the State of Tennessee License – no exceptions.

This documentation is to be furnished to the Department of Codes Administration, Administrative Office, before issuance of Plumbing Permits.

**STEP V**

Once approval is granted, the applicant will be allowed to obtain Plumbing Permits.
