We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

- (b) A person engaged in the sale or distribution of tobacco, smoking hemp, or vapor products shall demand proof of age from a prospective purchaser or recipient if an ordinary person would conclude on the basis of appearance that the prospective purchaser or recipient may be under thirty (30) years of age. In the case of distribution by mail, the distributor of tobacco, smoking hemp, or vapor products shall obtain from the addressee an affirmative statement that the person is twenty-one (21) years of age or older, and shall inform the recipient that the person is strictly prohibited from distributing any tobacco, smoking hemp, or vapor product, as defined by this part, to any person under twenty-one (21) years of age.

Staff Notes:

On February 23, 2021 staff received an MNPD Health, Safety, Morale's and Welfare complaint pertaining to **Egyptian Latino Market, 619 Millwood Dr, 37217**. As a result of the complaint Beer Board Inspectors conducted a Beer Buy Compliance Check and regulatory inspection at the establishment on March 9, 2021. They were found to be in violation of the following:

M.C.L. 7.08140C – Beer Sales to Minors (2nd Offense; x2)

T.C.A. 57-5-301(A)(1) - Identification Required (x2)

M.C.L. 7.08.030B – Type of permit violation by allowing on premises beer consumption
