CALL TO ORDER

Chairman John Green mentioned ordinance No. BL2006-1050 regarding the appeals process of the Traffic and Parking Commission.

"If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission's decision. We advise that you seek your own

independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met."

Motion to comply with the Governors Executive Order 16 regarding electronic meetings:

"The items on the meeting agenda constitute essential business of this body and meeting electronically is necessary to protect the health, safety, and welfare of Tennesseans in light of the COVID-19 outbreak" **John Green** motioned for approval of the Motion to comply with the Governors Executive Order 16 regarding electronic meetings. **Sara Lee Woods moved for approval. Faye DiMassimo, Mayors Office, gave an update of the Transportation Plan.

- a) CD 9: Authorize speed limit reduction on Cheyenne Boulevard from Neelys Bend to Bubbling Wells Road, from 40 mph to 35 mph; requested by CM Hancock
- b) CD 16: Authorize a traffic signal at Armory Drive and Sidco Drive; requested by NV5
- c) CD 23: Authorize a truck restriction on West Hillwood Drive from Charlotte Pike to Hillwood Blvd; requested by resident

Approval was made by Freddie O'Connell. Nora Kern seconded. The Consent Agenda was approved with no opposition.

a) CD 19: Authorize a valet zone at 500 Broadway; requested by Premier Parking

b) CD 19: Authorize a valet zone on the south side of Demonbreun Street near 1st Avenue; requested by The Register

Nora Kern made motion for Item A and B to be deferred one-month, Seconded by Officer Michael Gilliland. Items were deferred with no opposition.

c) Bill 2020-492: An ordinance to amend Section 12.36.110 of the Metropolitan Code pertaining to weight restrictions on certain roads

Council Member Rosenberg presented Bill 2020-492 and clarified that he would like to amend the language to better clarify the number of trips allowed for trucks on the specified roads. The revised bill would state "up to 18 trips per week". The Commission asked if the item could be deferred 1 month for the bill revision.

Item C was deferred 1 month with no opposition

b) CD 17: Appeal staff denial for an all way stop at Kirkwood Av and Vaulx Lane; requested by CM Sledge

Sara Lee Woods made motion for Item B approval. Nora Kern seconded. Item B was approved with no opposition.

 c) CD17: Appeal staff denial for an all way stop at Rosedale Av and Hurdwood Av; requested by CM Sledge

Ms. Patterson spoke in favor of an all way stop at Rosedale Av and Hurdwood Av. Derek Hagerty presented the warrant of the all way stop. Officer Michael Gilliland spoke about speed control policy. Officer Michael Gilliland made motion to defer Item C one month. Sara Lee Woods seconded. Item C was deferred one-month with no opposition.

BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee, and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five (5) days thereafter.
