  - 1. FY22 Restorative Arts Guidelines

Nichole Robinson updated the Committee on current updated for the Restorative Arts program and major updates to the FY22 Guidelines which included:

- FY22 Application and Programming Dates:
  - o Application opens April 18, 2021 at 11:59 pm
  - o Applications due May 14, 2021 at 11:59 pm
  - Staff eligibility review will take place between May 17-19, 2021
  - Scoring and Review Panel will take place by May 28, 2021
  - Award allocations reviewed by GFC during June meeting
  - Award allocation will be confirmed by Arts Commission during June 17,
     2021 meeting
  - Award announcements will be made by June 18, 2021
  - o Programming may begin any time after July 1, 2021- June 11, 2022
  - End of Year reports are due by June 15, 2022.
- Allowing individuals to be providers
- Including administrative competence in the scoring rubric
- Adding Deterrence and Prevention category which is under Probation

The Committee asked for more details regarding the definition of deterrent youth and the program budget. The Committee discussed how the program was growing and how that fit into budgetary needs and the needs of the Juvenile Justice Center.

A motion to approve the FY22 Restorative Arts Guidelines was offered by Commissioner Dow and Commissioner Powell seconded.
