MINUTES METROPOLITAN SEXUALLY ORIENTED BUSINESS LICENSING BOARD

The Sexually Oriented Business Licensing Board held a meeting on May 12, 2021 at 4:00 p.m. Members Jonathan Richardson, Ashley Wood and Lynne Ingram were present. Members Loren Russell and Amna Osman were absent. Attorney Matthew Garth and Inspector Christine Gibson were present. Chairman Jonathan Richardson called the meeting to order at 4:04 p.m.

Ms. Wood made the motion to approve the minutes for the meeting of January 27, 2021. Ms. Ingram seconded the motion and the Board voted unanimously.

The meeting for February 10, 2021 was canceled; therefore, the following new entertainer permit applications from January 28, 2021 to February 10, 2021 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3241, 3242, 3243, 3244, 3245 and 3246. In addition, the following renewal entertainer permit applications were approved: 926, 942, 1842, 2221 and 2769. There were no new or renewal business applications during this time period.

The meeting for February 24, 2021 was canceled; therefore, the following new entertainer permit applications from February 11, 2021 to February 24, 2021 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3247, 3248, 3249, 3250 and 3251. There were no renewal entertainer permit applications during this time period. Also, there were no new or renewal business applications during this time period.

The meeting for March 10, 2021 was canceled; therefore, the following new entertainer permit applications from February 25, 2021 to March 10, 2021 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3252, 3253, 3254, 3255, 3256, 3257, 3258, 3259, 3260, 3261, 3262 and 3263. In addition, the following renewal entertainer permit applications were approved: 2326, 2449, 2605 and 2610. There were no new or renewal business applications during this time period.

The meeting for March 24, 2021 was canceled; therefore, the following new entertainer permit applications from March 11, 2021 to March 24, 2021 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3264, 3265, 3266, 3267, 3268, 3269, 3270 and 3271. In addition, the following renewal entertainer permit applications were approved: 2513, 2606, 2797, 2960, 3054 and 3144. There were no new business applications during this time period. The following renewal business application was approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): #253, Pure Gold's Crazy Horse.

The meeting for April 14, 2021 was canceled; therefore, the following new entertainer permit applications from March 25, 2021 to April 14, 2021 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3272, 3273, 3274, 3275, 3276, 3277, 3278, 3279, 3280, 3281, 3282, 3283 and 3284. In addition, the following renewal entertainer permit applications were approved: 1403, 2313, 2786, 2909, 2958, 2967 and 3069. There were no new or renewal business applications during this time period.

The meeting for April 28, 2021 was canceled; therefore, the following new entertainer permit applications from April 15, 2021 to April 28, 2021 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3285, 3286, 3287, 3288, 3289 and 3290. In addition, the following renewal entertainer permit applications were approved: 935, 1800, 2003, 2498, 2768, 2918 and 2934. There were no new or renewal business applications during this time period.

Ms. Gibson informed the Board that the following new entertainer permit applications were in order from April 29, 2021 to May 12, 2021: 3291, 3292, 3293, 3294, 3295, 3296, 3297, 3298, 3299, 3300 and 3301. Ms. Wood made the motion to approve the permits. Ms. Ingram seconded the motion and the Board voted unanimously.

Ms. Gibson informed the Board that the following renewal entertainer permit applications were in order from April 29, 2021 to May 12, 2021: 411, 2461 and 6941. Ms. Wood made the motion to approve the permits. Ms. Ingram seconded the motion and the Board voted unanimously.

Ms. Gibson informed the Board there were no new business applications during this time period. She also informed the Board that the following renewal business application was in order: #2646, Déjà vu of Nashville. Ms. Wood made the motion to approve the renewal business application. Ms. Ingram seconded the motion and the Board voted unanimously.

Ms. Gibson presented her Inspector's report to the Board. She advised that the following businesses were in compliance during regular inspections: Pure Gold's Crazy Horse, Déjà vu of Nashville, Hustler / Kings of Hustler, Jenna's Toy Box (Dickerson Road), Jenna's Toy Box (Gallatin Pike) and Lion's Den.

This concluded their business. Ms. Wood made the motion to adjourn. Ms. Ingram seconded. The Board voted unanimously and adjourned at 4:24 p.m. until the meeting of May 26, 2021 at 4:00 p.m.
