BOARD APPROVES AMENDMENT TO GRANT REQUEST FOR REPAIRS TO MISSION SHELTER BY LAKE SEVIER

No changes are proposed to the funding structure – all costs will be borne by Friends of Shelby Park and Bottoms.

BOARD APPROVES AMENDMENT TO GRANT REQUEST FOR REPAIRS TO MISSION SHELTER BY LAKE SEVIER

The total cost of \$35,000 mentioned in the previous grant request for repairs to the Mission Shelter is an estimate. Friends of Shelby Park & Bottoms will cover any additional costs over this amount. Friends of Shelby proposes to hire the Metro Parks carpenters to complete the framing and painting work and use professional contractors for the roofing. Each month Friends of Shelby Park & Bottoms will receive an invoice from Metro Parks for the carpenter payroll amounts associated with the repairs to the Mission Shelter. Parks will then invoice Friends of Shelby Park & Bottoms for the payroll amounts to be reimbursed.

Upon motion of Mr. Anderson, seconded by Ms. Hughes, the board approved the terms of the amended agreement. No money will be donated to Metro Parks. Projects will be paid for directly by Friends of Shelby with no match needed from Metro Parks.

BOARD ACCEPTS IN-KIND DONATION VALUED AT \$4,000 FOR IMPROVEMENTS TO CENTENNIAL ARTS CENTER SHED ROOF PROJECT

Correspondence received from Ms. Michelle Craine, President of Creative Parks Nashville, requesting the board to accept an in-kind donation for improvements to to the Centennial Arts Center shed roof project with an estimated value of \$4,000.00. Improvements include electrical installation and addition of an industrial ceiling fan. In the case that improvements total more than \$4,000.00, Creative Parks Nashville will be responsible for paying those amounts.

X. REPORT OF THE DIRECTOR

Ms. Odom announced:

- The May 20, 2021 Metro Council budget hearing went well, Metro Parks is receiving positive attention particularly because of the role the department played during the COVID epidemic. Thank you to team parks and the Parks Board for the advocacy and support. The FY22 budget should be passed by the end of June.
- The formal public input period for the request to rename Hadley Park will end on June 8, 2021 at 4:30 pm. The information will be compiled and submitted to the Parks Board after that.
- Human Resources Staff at Parks has developed a code of conduct and ethics for the department. This document has been approved by central HR.
- The consolidated maintenance division has been very busy with routine work, repairs and deferred maintenance.
- Our summer enrichment program started today at all 25 community centers. All outdoor pools and spray pools are open.
- Planning is underway for the 50th anniversary of the Centennial Arts Center. The celebration will be next year and will include history and acknowledgement of the Art Center.
- We are piloting a clay class for seniors at Hadley Park.
- Wave Country opened for summer season on May 29.
- Ms. Odom has spoken with Stan Fossick, former board member, he is traveling and is expected to appear in person soon to be honored for his service.
