Good Evening,

I'm writing to you as a concerned citizen of the Antioch area of Nashville, TN. I urge you to vote NO on BL-133 due to the following concerns:

1. There are multiple versions of the inclusionary housing bill that doesn't seem to be properly vetted

2. The growing number of apartments vs single-family homes in Antioch doesn't leave room for retail space that's desperately needed to revitalize the area.

3. The increase in Davidson County students in the area will be zoned to schools that are currently overcrowded, even with a new school being added in 2017

4. There are currently no plans of action in place to implement sufficient & efficient public transportation for the influx of residents (if one wants to ride the bus to Brentwood from Antioch, they would still have to take a bus downtown to transfer to a bus to go to Brentwood vs the ability to take a bus directly from Antioch to Brentwood)

5. There's currently a high number of affordable housing developments scheduled for Antioch & Madison, but none or very few for Crieve Hall, Brentwood, Berry Hill, Bellemeade, Bellevue, the Vandy area, Sevier Park or Woodmont

6. I would love to see developments like Elliston 23, West 46th, One Metro Center or Station 40 in our area. We're told by developers that land in Antioch & Madison is cheaper than other parts of Nashville, so these types of developments can be built in our area & still be affordable.

7. The income values being used based on HUD guidelines are skewed & incorrect in determining what the median income is & where residents will fall along the lines of being eligible for affordable and workforce housing
