Dear Chairman Adkins and Commission members:

Almost two years ago, members of the Metropolitan Council listened to the citizens of Nashville and their requests for action to address the dwindling stock of affordable and workforce housing in Nashville. The Council established a self-imposed deadline on our continuing conversation and enacted legislation tasking the Metro Planning Department with determining an implementation plan. We knew at the outset that our success depended upon striking a compromise among a diverse cross-section of affordable and workforce housing stakeholders.

In conjunction with the Planning Department, we worked diligently to bring stakeholders to the table. Vice-Mayor David Briley created the Ad Hoc Affordable Housing Committee and asked that I chair it. Immediately, I endeavored to establish a transparent process and to invite everyone with a sincere interest in addressing the issue to do so collectively in a series of publicly noticed meetings. The process has been difficult at times, but it has succeeded in bringing the conversation front and center. Our work to date remains transparent and accessible. Most of our meetings are taped and available on the Metro Nashville Network as well as YouTube. The Planning Department routinely shares up-to-the-minute information on their website. I even set up a Facebook page to post information for interested parties. Transparency has been crucial throughout this process, inasmuch as no legislation can or should expect to become law without the informed support of its stakeholders.

After months of research, consultation and review, the staff of the Planning Department presented two ordinances – first to the Planning Commission, which conducted an exhaustive and widely viewed public hearing – and then to the Metro Council. We used the enormous amount of information gathered by the Planning Department and its consultant, together with feedback we had received, to draft five (5) pieces of legislation to move this process to the next phase of implementation.

- 1) <u>Incentivizing inclusionary housing (BL2016-133)</u> Crafted by the Planning Department, this ordinance is targeted to create affordably priced rental units in residential projects that request additional development entitlements;
- 2) <u>Comprehensive Plan (RS2016-317</u> Tasks the Mayor's Office, through its Office of Economic Opportunity and Empowerment, with establishing and implementing a comprehensive plan for preserving, funding, and creating affordable and workforce housing, including measurable goals and metrics.
- 3) <u>The Barnes Fund Resolution</u> Updates legislation governing the Barnes Fund and its Commission to define their role in implementing affordable and workforce housing development;
- 4) <u>PILOT funding Resolution</u> Increases the options for using PILOT funding for affordable and workforce housing;
- 5) <u>Grants program ordinance</u> Creates a grants program to provide funding for incentives for projects that build inclusionary housing, the framework for which was set forth by Matt Wiltshire, Director of the Mayor's Office of Economic and Community Development.

Many of these pieces of legislation – or amended versions thereof – will soon come before you for your consideration and approval. Indeed, Metro Council Ordinance BL2016-133 (No. 2916Z-001TX-001) which incentivizes inclusionary housing appears on your Agenda this Thursday, July 21st. I ask for your support of this legislation, and those bills that will follow, with assurances that my committee, the Metro Council as a whole, and the Planning Department staff have worked thoroughly, transparently, and inclusively to craft legislation that the citizens of Nashville have requested.

RE: SUBSTITUTE BL2016-133 – INCLUSIONARY HOUSING

On behalf of the Nashville Area Chamber of Commerce, we are writing today to respectfully ask that the Planning Commission defer its decision on Substitute Ordinance BL2016-133. The Chamber is committed to creating affordable housing through public/private partnerships that increase the supply of housing through voluntary and incented programs with a clear, reasonable process.

The Chamber appreciates the changes made to Substitute Ordinance BL2016-133 and are pleased that the Mayor's Office has released the proposed grants bill, providing a clearer picture on how Substitute Ordinance BL2016-133 could be implemented. We find, however, that in its current form, we cannot support Substitute Ordinance BL2016-133. The Chamber has sent Councilmembers Allen and Bedne a list of concerns and proposed amendatory language for the legislation. Of those concerns, the three primary issues are:

- 1. The administrative role placed on property owners in monitoring and enforcing affordability;
- 2. The lag property owners will experience in receiving grant payments for the affordable or workforce housing created; and
- 3. The cap on grant payments of up to 50 percent of the property tax increment generated by the development.

Housing affordability is a key issue for the Chamber. Our board and members understand the importance of providing affordable and workforce housing to attract and retain the diverse workforce needed for our growing economy. The Chamber looks forward to continuing conversation on the issue, but at this time we are unable to support BL2016-133. We urge the Commission to defer its decision until more discussion – and hopefully more compromises – can be reached.
