RE: Proposed Urban Services District Annexation

Dear Chairman Adkins and Members:

I regret that I will be unable to attend the Planning Commission meeting on Thursday, August 25, 2016 concerning the proposal to expand the Urban Services District. I am disturbed that as a Member of Council, I was not notified the matter was being discussed or under consideration at the meeting, and only learned of it when it was already public knowledge in my district. The entire Hermitage portion of my district will be annexed into the urban services district.

A large number of my constituents have already expressed their opposition to the annexation. Additional street lighting and garbage service provided by Metro will not be enough services to justify the increase in property taxes. For years the main reason for annexation was urban services level fire protection, which would result in a homeowner's insurance premium reduction. That is no longer the case due to the level of fire service in the GSD.

I am aware that some council members have asked for this in their district. In order to accomplish this, the annexation must be greatly expanded to meet the requirements that all areas in an annexation be contiguous with the urban services district or will be after the annexation. I strongly urge the commission to not go forward with the plan until after all affected areas are clearly in favor of it.
