Good morning, In reviewing the proposed USD annexation to be discussed at today's meeting (http://www.nashville.gov/document/ID/f611fb94-4983-40e6-8f29-24b50fec1e44/August-25-2016-staff-reports), I'm concerned that the Annexation Costs that are provided have a calculation error. Example: I'm in District 3. Page 171 of 219 of the document at the link above states the total projected cost for ANNEXATION TRASH is \$8,600. However, the Automated Cart Pick-up - Contractor cost alone is \$34,447 per month. Shouldn't the total for the monthly cost be \$43,107 and the total estimated annual cost be \$517,284? This also changes the totals at the bottom of the page.. making the Estimated Annual Cost \$707,384 and the Variance Total \$160,692. This same calculation error appears on other District Estimations I've reviewed as well. I admit that I'm opposed to the Annexation in my district as we will not benefit from any fire suppression expansion plans, already have relatively close police precincts, I like my private trash collection AND can live without the light pollution of street lights. In any case... your decision should be based on sound numbers and facts. Thanks.
