Good morning! I hope all of you are doing well.

I would like to ask for a moment of your time to express my adamant opposition to the proposed SP at the corner of Elvira and Keeling in East Nashville.

The proposal being put forward calls for 180 units and 220 parking places deep within a residential neighborhood. There are no sidewalks, convenient access to public transit or connector corridors large enough to handle this density at this location. 220 additional cars attempting to access Gallatin Rd and Trinity in this location down narrow neighborhood streets will create a traffic disaster of epic proportions. It also should be noted that there are no traffic lights to facilitate traffic flow onto Gallatin or Trinity at Keeling or Elvira. It is already becoming next to impossible to turn onto either of these main streets at peak traffic times and is only getting worse.

In addition this level of density does not fit within the character of this location. Development of this area has been extensive in recent months and is predominately single family homes. Density of this level is more appropriately placed on main corridors with sufficient infrastructure and transit to handle this added strain. It is entirely inappropriate at this location.

While it is true that this location is currently characterized by the T4-NE designation it is not a fair representation of this location and the intent of the NashvilleNext usage suggestion should be revised. It clearly states in the description of T4-NE development that "If existing streets cannot support the use generated by the evolving urban neighborhood, improvements to these streets or RECLASSIFICATION of these streets may be necessary." It also clearly states that "Access to mass transit is provided in convenient locations that allows for coordination with sidewalks and bikeways." This is demonstratively NOT the case.

Thank you very much for taking a moment to consider my concerns with this proposed development. I am supportive of development in general but we must be EXTREMELY thoughtful and wise about how we move forward in East Nashville. This is the wrong place for this development.
