Dear Mr. Sewell -- It was a pleasure meeting you and your colleague the other evening at the East Hill community meeting. I wanted to write to reiterate and elaborate on my opinion regarding changing this area's overlay from T4 NE to T4 NM.

I own and reside at 1010 Elvira Ave, and my family wishes to remain under the existing policy. I would like to speak to Elvira Avenue only and encourage the Planning staff to consider carving out Elvira if there is a change to the rest of the overlay area.

As was stated in the meeting, the request for review came from the leadership of the East Hill Neighborhood Association. This leadership, in my opinion, is quite biased against development in general and does not speak for me and many others on Elvira. In fact, the most vocal in East Hill and its leadership do not live anywhere near Elvira Ave.

It has been made clear that the request was in response to the recent failed SP filing for the Elvira Development. This overlay change is championed by them because they believe it will stop or make more difficult any development beyond that allowed by present zoning. Your explanation made it clear that development and SPs would still be considered with NM overlay, but I believe removing the NE overlay will deter developers somewhat from paying attention to our area and bringing sidewalks, road expansion and infrastructure improvements to our street. We do have at least one very unusual parcel owned by the Cogdill family which is ripe for responsible development. This could include some smaller, more affordable units in condominium buildings which would resemble nothing on our street. In fact, very little on our street resembles something else on the street anyway, so what is there to maintain?

I am a licensed real estate agent and feel that our street will benefit if left under the current overlay. It is my hope that Keeling Ave, Elvira Ave and Thomas Ave will eventually become part of a walkable community generated by the Multi-Use neighborhoods along the Trinity Lane corridor. I respect my neighbors very much for speaking out against projects which would serve as traffic nightmares to our general area, but to seek unnecessary changes in order to stop what I consider progress is unfair to me and the owners on my street who see something different for our neighborhood and our investments.

I look forward to hearing the recommendations of your staff and the Commission.

Subject: East Hill change from Neighborhood Evolving to Neighborhood Maintenance

Greetings Mr. Sewell - I'm sad I missed the community meeting last week on the proposed overlay change for sections of the East Hill neighborhood from T4 NE to T4 NM. I am writing to share my thoughts and concerns on this proposed change.

I purchased my home at 1012 Elvira Avenue in October 2011. Since then, there have been 26 new houses added to this street (not including 2 more currently being built). Elvira Avenue isn't even half a mile long (clocks in just under .4 miles). Elvira Avenue serves as a vehicular cut-through from Trinity Lane to Gallatin Pike, with vehicle drivers often pushing 45MPH or greater on this street. There are many walkers (and a handful of bike riders) who are either going to work, running errands, or walking for pleasure. They are at risk of injury or death due to the lack of separated infrastructure as well as the failure of MNPD to enforce traffic codes on this side street.

However, that's not the issue at hand, though I feel it plays a large part in my rejection of the proposed change in the community plan.

Based on my reading of the plan, a move from NE to NM would reduce the chances (what little they may be) of Elvira, Maynor, Iverson, or other side streets to be in line to have sidewalks. I am open to being corrected if my interpretation is not right!

At the moment, attempting to talk with developers as they cash in on our neighbourhood and pleading for sidewalks to be put down within the framework of the Metro Public Works' ST-210 guidelines for local street sidewalk standards and working within the Complete Streets mayoral executive order is about the best I can do. I was excited about a recent proposal from Councilwoman Angie Henderson to require developers to place sidewalks in front of new builds and multi-unit properties, but that is

becoming toothless as well in preparation for second reading at Council and would result instead in another "in lieu" fund.

Basically, Elvira Avenue has now seen a load of housing development that has not resulted in anything resembling safe walking or biking infrastructure, and I am concerned that the inaction of our councilperson on this issue combined with certain future development capabilities on our street and a change to NM will reduce Elvira Avenue's chances to have any type of sidewalk possibilities in future. I am a former board member of and current volunteer with Walk Bike Nashville; I own a business called Bike Fun which is dedicated to getting Nashvillians out on two wheels (www.nashvillebikefun.com); and I am a passionate advocate for human powered transportation - so much so, that I have been dubbed a "self-appointed hall monitor" for the sidewalks we have precious few of in this part of Inglewood. (I'll wear that moniker with pride.)

I am OPPOSED to the change in community plan for this section of East Hill.


