Dear Planning Commission,

I request you disapprove the proposed zoning change, and keep the school site in it's original location.

I am a Shelby Hills resident and live only a couple blocks from the proposed rezoning at Cayce Place. I regularly participate in Cayce town halls regarding the redevelopment project.

The Cayce master plan was developed over several years and through much community input. The plan places civic uses in a cluster, located in close proximity to each other and to the community amenities and parks. This plan has been vetted and should not be changed for seemingly petty and irrational reasons.

Moving the school site would reduce walk-ability; remove easy student access to amenities such as parks, trees, basketball courts, and the library; create safety dangers for student pedestrians crossing streets; and would result in multifamily buildings separating school buildings from such amenities. The proposed reasons for the change include "tension between schools" and "traffic". Neither of these are based upon real facts or issues that are important to the neighborhood. Squabbles between competing school corporations/administrations should not be given weight above the student and community needs. The proposed zone change is detrimental to students and the neighborhood and is not based on any real facts or issues important to the community.

With Tennessee near the top of the list for childhood obesity, it is shortsighted, poor decision to move a school away from recreational and fitness amenities. Walking and recreation should be promoted, not ignored. Additionally, school children benefit from proximity to green spaces, which create a better learning environment and increased educational achievement.

In regards to traffic, moving the school location would negatively impact traffic conditions in the single family residential neighborhoods of Shelby Hills. This would lead to traffic congestion in existing, historic neighborhoods. Traffic issues are reduced when schools are cited adjacent to each other in an organized fashion, as originally vetted in the Cayce Master Plan.

Greetings,

I will not be able to make it to the meeting on 9/14 however I would like to state the following regarding Item #11a:

It doesn't make sense to propose a new location now, when the well-thought-out Master Plan already indicates the location of the new school that not only will save existing trees, but also manages traffic flow, has much better safety, is near/adjacent to the community park and library, and does not force school-age kids to cross busy roads. Most importantly, the original plan directly addresses the needs of the children and parents in the neighborhood.

I have read the arguments in favor of the move to location #2 - stated on page 51 of the staff meeting notes for 9/14- as:

- Space and separation between the proposed site and the existing school location will be a positive for each school in maintaining their own identities;
- Nashville currently does not have two charter schools sited next to each other; and
- Traffic (pedestrian, bus and car traffic) separation to each of the school sites will reduce congestion and parking demand in the area.

The first item is not valid, and is arguably incommensurable. The second point makes no sense as it has no relevance to the needs of the community and the third item of concern is quantifiable via traffic engineering metrics and I assure you will not stand up to analysis regarding congestion and parking.

In so being, I must conclude that the request now to change the location is simply: petty politics at play and an attempt to delay the project. We must call it what it is. I say this as a parent that whole-heartedly believes there should be educational choice for everyone, including the folks within Envision Cayce as well as the surrounding areas, with the intent of accommodating diversity in order to create to create unity. The attempts to create such delays via last minute changes to the project are representative of the attempt for opponents of charter schools to gain in political agenda and prevent MDHA from working with or advocating charter schools. I do not believe this is best for the children and parents in this area, nor should the planning commission get involved in such squabbles.

Therefore, I agree with the staff recommendation and I urge the planning commission staff to disapprove this move.
