It is critical to develop this plan thoughtfully as it is the first of Nashville's transit-oriented developments.

The problem for me as a concerned citizen and frequent attendee of Mayor Purcell and Brenda Wynn's <u>Transit and Affordability Committee</u> (appointed by Mayor Barry) is that NONE of the recommendations are included in this plan, and it could by default become the template for all the 12-15 subsequent transit districts.

There should be no rush — and the commission, the public and the Council should be given time to consider this first zone carefully, including ample public hearings. Otherwise Nashville may continue to lose neighborhood character and housing for existing

residents. Elements excluded from the plan include: guidelines for building a portion of new building as 'affordable housing' so that none of the future income stream from the *new tax increase* is granted to developers without some contribution to the affordable housing stock; prohibiting short-term rentals in new construction projects *that receive public financing*; and simplifying the planning process to give fairer access to builders (especially some of the smaller, local ones focused on the lower-income population).

There SHOULD be no reason to rush on this. We need to get it right for all the people who live and work in this city.
