Dear Colby, Freddie and Planning Commission:

My name is Terri Chapman and my family has owned 1721 15th Avenue, since I was twelve years old. I am fifty five now and I can remember the day moving trucks came to our modest home, off Jefferson Street, in route to South Nashville. As a little girl, I was saddened by the move however; my granny assured us kids that we would make new friends and most importantly, we would attend better schools. It was her plan for every one of her children and grandchildren to own a home and to receive a college degree. That was her mantra for many years. At her death, all of us "kids" had purchased a home, attended college and started businesses. This success story happened in two generations.

Back to the Edgehill story:

When the moving men pulled up to the red brick house, on the corner of 15th and Wedgewood not far from Belmont College, I was amazed. It seemed like a mansion in comparison to the home we had left on 28th and Fomosa in North Nashville. In this home, I had my own bedroom and there where two bathrooms and a basement, things I had never seen before in the homes where Black people lived in my old neighborhood. I also noticed people of different races walking around the neighborhood. Many of them were college students from Belmont. That was different for me also. Coming from North Nashville, everyone who walked around the neighborhood then were of the same heritage. I could instantly tell this was going to be a very different place from where I came from.

One of the first things, any self respecting kid does to make new friends is to find the nearest playground. After the moving trucks left and granny told us the rules of the new neighborhood, we skipped down the street and around the corner to Murrell School. Immediately my brother, cousins and I realized we were in the right place at the right time. We were just in time to play "Telephone", a game

where kids stand in a line and whisper phrases to each other. It was interesting to see how the beginning phrase became distorted as it was whispered over and over again. By the time the phrase was repeated by the last person in line, the meaning was always something totally different from the original words uttered.

"Telephone" was an interesting game. Depending upon who the players were that day, and their personal agendas, the beginning phrase could take on a life of it's own. Due to the intentional efforts to "twist" or "spin" the outcome of the game, the most cleaver kids could "flip" the phrase. Bullies, or those with the loudest voices in the neighborhood, would deliberately change the phrase to confuse everyone. The popular/active kids would try to bring about peace during the game. The quiet kids, those who seemed not have any say so in the matter, just went along with whomever seemed to be the most powerful at the time, just to get along. I tell this story because I feel this is what is happening during the approval process of the Overlay in Edgehill. We have bullies, quiet people and those who are active in the community trying to make sense of this ordinance, with much input from those who do not want it to pass. (Dissemination of inaccurate and untrue statements pertaining to the Overlay process and those who worked on it.)

It would be absurd for me to refer to the Opposition as bullies however; I do feel that they have stoked fears in many uninformed residents and property owners. (People who have never read the Overlay for themselves) I have knocked on approximately 178 doors in the past seven days conducting a Community Needs Assessment. We have spoken with roughly 30% of the people who live here. I was shocked at the information that has been communicated about the Overlay or residents interpretation of it in general. I had people to tell me that they could not paint their homes, that they would not be able to sell their homes at a good price and that their taxes were going to go up solely because of the Overlay. (Taxes are going up everywhere in the "It City") One lady said she didn't know what the Overlay had to do with African American history. (Sadly, she was Black) It was a very rewarding and insightful experience. What I learned was the "Telephone" game had taken on a new meaning in Edgehill.

The modern day "Telephone" game in Edgehill began with a few people who are focused on their own property rights and not the neighborhood and it's history as a whole. These individuals use email, FaceBook, social media and list servs to "stir up" dissention and to drive a wedge between long time African American property owners. (We saw this tactic used to divide us during slavery) Half truths are being disseminated about the Overlay process and the citizens who worked hard, for almost two years to develop it. You would not believe the lies I have heard over a bottle of water on a front porch. The Opposition is loud, professionally organized by Republican operatives, rude and very aggressive in their fight for their property rights. (Trump playbook) I have no problem with their views, we still live in a democracy. The only problem I have with their argument is the fact that they refuse to believe that the Metropolitan Government will be efficient and organized enough to handle their requests once the Overlay becomes legislation. That is yet another issue that needs to be addressed in a broader sense.

As any kid knew on the Murrell School playground, eventually the "Telephone" game became boring. Kids who wanted to know what the original phrase was, were surprised at how it had changed by the end of the game. Some of us asked questions to see who had really changed the phrase to something completely different. Sure enough, it was always the bullies. (That's why I took it upon myself to go door to door visiting the Opposition. I wanted to hear what they had been told firsthand.)

It is my hope that the Edgehill community can heal after the Overlay is passed. No legislation will make everyone happy. The Overlay will slow down irresponsible builders and those seeking to simply build non owner occupied Air BNB's. The property next door to my mom recently sold and she is afraid another investor/developer will build a tall and skinny which will block out her sunlight. God forbid, if it becomes a haven for weekend bachelorette and bachelor parties. Who wants that for their elderly parent? What happened to the Edgehill neighborhood I moved into years ago? There was a time when we knew our neighbors and they knew us. Unfortunately, that is not the case now. It has become a transient neighborhood, much like the new Nashville.

I, Jennifer Jones, am in complete support of the Edgehill Conservation Overlay. I purchased my home at 1031 15th Ave S in 1999 and have resided there since. My home was built in 1915. My parcel is on the corner of 15th Ave S and Tremont.

I write this letter to request that each of you please utilize your respected voices to help protect the architectural and historic character of Edgehill's historic sites by working to pass the Edgehill Conservation Overlay. For this historic neighborhood to survive, Edgehill requires assistance in stabilizing our neighborhood and requests expertise in helping to manage our growth and change through public design review.

Edgehill also needs assistance in helping to save our greenery by preventing the destruction of trees, hedges and grass. In July, 2017, I was forced to consider moving approximately 181 linear feet of hedge. Experts were hired to analyze the process. I was informed that should I move my hedges, it would take 20 years for the microhabitat to develop to the point it was that specific day.
