Having grown up in suburban Atlanta, GA and studied architecture in downtown Atlanta, I would like to share my experience with large stadiums and event spaces. Suffice it to say, I've been exposed to some good and some very poor architecture and planning decisions, as well as how those decisions can impact neighborhoods over time.

Stadiums, simply because of their large scale, can negatively effect the granular nature, affordability, activity, and walkability of urban neighborhoods. Even the most sensitive architecture cannot often overcome the negative consequences of scale.

In Nashville, the Fairgrounds are important open spaces, imperative to our urban puzzle, and an amenity for the entire city. I feel that the Fairgrounds character would be permanently and negatively changed by a large stadium. Also, we already have a stadium in Nashville. Imagine what could be accomplished if the money slated for a new stadium were invested into upgrades to the existing stadium, including public transportation to and from.

I do not appreciate the way that contemporary cities seem to be held hostage by professional sports teams. I think that international football could be great in Nashville, especially for members of our community who have grown up in a city or country where soccer is very much a part of the culture. However, I do not feel as though a new stadium should be forced upon our city, especially if it calls for the city to donate public land.

All of my personal and professional experience leads me to believe that a new stadium, as proposed, is a decidedly bad planning decision. I realize that I am but a single voice, but I would hate for my home city of 15 years to repeat the mistakes of my childhood city decades after. Thus, I cannot support funding or planning or zoning changes that would lead to a newly constructed stadium as proposed.

Hi Commissioners!

As a Donelson resident, my family and I traverse Elm Hill Pike regularly. We were drawn to this area with our young family (I gave birth just two weeks after moving in!) because of the established character of the neighborhoods - yards for playing and pets, room for box gardens, quiet streets. We are hopeful that our children will be able to grow up in the sort of environment that I had as a Tennessee native. Rezoning the 13+ acres along Elm Hill Pike from RS10 runs opposite to those hopes. We do not believe that the proposed development is in keeping with the character of the area. It does not reflect our values. I understand that as is, the zoning will allow for 50-ish new residences to be built. My question is why that option isn't being considered. Fifty more dwellings will impact the traffic, but not to the extent that 100+ would. It would also allow for actual yards, which means safety for children, and encourage the sort of community we so appreciate. I am asking you to weight my voice and the voices of my neighbors above the financial interests of developers. We are the people who make our city the wonderful place it has been for years. Please consider the impact we can have to keep it that way for the future.

Dear Commissioners,

This is a letter of support for the Edgehill Neighborhood Overlay.

This process to get to this ordinance started in December 2016. In the packet you have received from our committee this long timeline is presented in detail. When we start we did not know what we needed or wanted. What this group of residents did know was that the historic Edgehill we love was under threat of being lost in the headwinds of "development."

After consulting the Planning Commission staff, the Historic Commission staff, and our two Council persons, we considered the options before us. We chose the Neighborhood Conservation overlay as it was the least restrictive but protected proportionality and character for the remaining contributing homes. The decision-making process was open to all with many public meetings and the posting of all activities and options on the internet at edgehillcoalition.com.

The opposition from some developers is understood. This will limit to some degree the amount of square footage they are maximizing at present. This would translate into lower immediate returns for resale and/or Airbnb rentals. For many of us who have lived here for decades we think limits on massive structures and on more non-occupied Airbnb's are a plus as we try to hang on to our sense of community for the long term.

For those who argue that their property rights are being trampled on, it is curious.

The argument that some make that they want no government interference belies

the current Metro Codes requirements. An owner today has to present a site plan, plans, and approval

from the various Metro Agencies to pull a building permit. This overlay does add the step of approval

from the Historic commission with no addition fees. The research we have found would indicate that

property values increase over time when neighborhood overlays are in place. Stability improves

property values.

As a white woman who has lived in Edgehill since 1988, it grieves me to see some newcomers

discount the African American history represented in these few blocks. The resilience of

of this community to keep on in spite of the intrusions of the majority interests, i.e. slavery,

de facto segregation, urban renewal, and some developers, instructs us that perseverance is a gift to

those who follow. The rich stories that have emerged in this process only reinforce our desire to pursue

this overlay. Honoring the past is our only hope of a better, more civil and respectful future.
