RE: <u>Deferral Request</u> for Forest View Park PUD Review Item #23 – April 14, 2016, Agenda PUD #23-85-P

Members of the Planning Commission:

My firm represents The Ridge at Antioch, Limited Partnership (the "Owner"), which owns the property within the Forest Park PUD that is the subject of Councilmember Karen Johnson's request for periodic PUD review per Section 17.40.120 H of the Metro Code. The PUD review request is set for consideration by the Commission this Thursday, April 14. It is my understanding that Councilmember Johnson has requested that the hearing on her PUD review be deferred for one meeting, to April 28.

The purpose of this letter is to inform the Commission that the Owner does not object to a one meeting deferral, but we would object to any additional delay. This matter is different from the usual situation in which an applicant or Councilmember requests deferral. The Owner has purchased land that is zoned to allow their proposed development and they have spent substantial money towards obtaining financing and receiving Metro approval to proceed with construction. The uncertainty of the PUD review process, however, puts the Owner in a precarious position. The Owner must either continue to spend money on the development approval process despite a risk that the zoning for their property will be changed, or the Owner can put the project on hold, which increases its holding costs and development costs.

Despite these concerns, in deference to the Councilmember, the Owner does not object to the requested one meeting deferral.

The Zoning Code lists the criteria for the Planning Commission's review of PUD revisions of older PUDs, which is Section 17.40.110.G. This is a separate application that needs to be reviewed against the standards included in that section of the Zoning Code.

When the request to review the PUD for inactivity was made, the review packet had already been sent as notification that a PUD revision had been submitted.

In accordance with the Planning Commission's Rules and Procedures, the Chairman and Executive Director will evaluate your request for a rehearing of the PUD revision.

As you requested, your application to review the PUD for inactivity will be recommended for a one meeting deferral at the April 14, 2016<x-apple-data-detectors://5>, Planning Commission meeting. The next Planning Commission meeting is April 28th. Please let me know if you have not received the staff report for that request, which was published earlier today.

I'm sorry for the delayed response. I've been out of the office due to a death in my family. An application to revise a portion of this PUD was submitted on February 11, 2016. As mentioned in your emails, the DRC-PRC packet was emailed to Councilmembers and Council Office Staff on Wednesday, February 17, 2016, to notify you and other Councilmembers of the applications filed for the March 24, 2016 Planning Commission meeting. For reference, that email is attached. After receiving the DRC-PRC packet, you requested a periodic PUD review on February 18, 2016, which met the filing deadline for the April 14, 2016, Planning Commission agenda. On February 23, 2016, notification of the request for a Periodic PUD Review was sent to the property owner and emailed to you. Planning staff does not have the authority to delay the PUD revision application that had already

The staff report for the March 24, 2016, Planning Commission meeting was emailed to all Councilmembers on March 18, 2016. The staff report included the revision to the preliminary PUD plan for Forest View. That email is also attached. Staff reports and agendas were available on the Planning Department website Friday afternoon, March 18, 2016. The case was also on the Planning Department's Development Tracker website

(<a href="http://maps.nashville.gov/DevelopmentTracker/#">http://maps.nashville.gov/DevelopmentTracker/>) throughout the review process.</a>

In response to your inquiry, there is a process to request items be reconsidered. As stated in the Rules and Procedures of the Metropolitan Planning Commission, in order to consider rehearing the request, as the applicant, you must state what conditions have changed or what new information is available now, which wasn't available for presentation to the Commission at the original public hearing. The request must be submitted at least 14 calendar days prior to the meeting at which the request will be considered. Any information provided will be used to determine whether there is cause for rehearing. Once that information is received, the Chairman and the Planning Department Executive Director will

review the request to determine if the information qualifies for a rehearing. Qualification for a rehearing is based on whether the conditions have changed or there is new information that wasn't available at the time of the first hearing.

- If the Chairman and Executive Director determine that the information qualifies for a rehearing, it will then be up to the Planning Commission as a whole to determine whether the information provided does in fact, serve as a cause for rehearing this case and, if so, schedule a rehearing for a future Commission meeting.
- If the Chairman and Executive Director determine that the information does not qualify for a rehearing, then the decision to deny the rehearing will be noted on the Commission's next available agenda. The Commission may, by a majority vote of the members present, overrule the decision of the Chairman and Executive Director and consider the request at a subsequent meeting. Your request to review the PUD for inactivity remains on the April 14, 2016, Planning Commission agenda.
