#### E. ACTION ITEMS

### a) Public Art - Fairgrounds Budget and Selection Process

Van Maravalli, Public Art Manager, presented the goals and opportunities for Public Art at Nashville Fairgrounds campus as well as artist selection process and budgets:

Phase I: Large Scale, "Iconic" Installation - Budget \$650,000

RFQ/Call to Artists: open to local, regional and national artists; Citizen Selection panel votes, interviews, and makes final artist selection; selected artist will work closely with Metro Arts and stakeholders to develop a site-specific design proposal; and PAC and Commission approve proposed design concept

Phase II: Smaller Scale, Integrated Installations - Budget \$300,000
REQ/Call to Artists: exclusive to local and regional artists: Scope and se

RFQ/Call to Artists: exclusive to local and regional artists; Scope and selection process to be determined

A motion to accept the PAC recommended funding approval for Phase 1 "iconic public art" project budget of \$650,000 for the Fairgrounds site, Phase 2 "integrated & functional

design public art" project budget of \$300,000 for Fairgrounds site, and the selection process for Phase 1 artist selection was offered by Commissioner Alvis, seconded by Commissioner Coffman, and the motion passed.

b) Americans for the Arts (AFTA) – National Arts Marketing Conference 2021 ED Caroline Vincent informed the board that Metro Arts has been approached to host the upcoming AFTA conference and presented a proposed acceptance letter to board. After discussion, no action was taken pending further conversation with AFTA about local benefits and establishing parameters associated with Metro Arts' role.

## G. Program, Project, and Operational Updates

Caroline Vincent gave the following updates:

- a) Office Move
  Planning for the office space at Metro Southeast campus is underway and the move date is expected to be in late June
- b) Finance Update
  - The budget hearing will be held on May 22 at 4:45. Commissioners are asked to arrive by 4:15 p.m.
  - Annual reports have been provided to Metro Council Members and the Mayor.
  - Audit findings have been received and will be shared with the board once they are released by the Office of Internal Audit.
- c) Hiring process
  Grants manager interviews will be held early May and references for prospective Public Art Coordinator are being checked.
