METRO ARTS MISSION: Drive an Equitable and Vibrant Community through the Arts

A. Call to Order & Welcome

The meeting was called to order at 12:10 p.m.

B. Arts in Action

Emily Waltenbaugh presented to the Commission highlights from the previous month. She shared a video created by XPayne to support the Mayor's Participatory budgeting process, an update on the Nolensville Pike transit shelters, details about the Restorative Arts programming underway, and an announcement of two calls for artists about to go out for the new Donelson Public Library.

Chair Schmidt asked if there were any questions or comments.

The Commission asked for clarification of the timeline and scope of the Nolensville transit shelter and utility box project. Staff clarified that due to several contingencies the project has been delayed but that it is in progress.

C. Approval of Minutes: August 19, 2021

Chair Schmidt asked if there were any questions or proposed changes to the minutes.

A motion to approve Arts Commission minutes from August 19, 2021 was offered by Commissioner Alvis Commissioner Roberts seconded, and the motion passed.

D. Guests: Metro Chief Diversity, Equity & Inclusion Officer, Andrea Blackman and Metro Human Resources Workforce Diversity Manager, Razel Jones

Chair Schmidt reviewed the role of equity work in the upcoming strategic planning process and Metro Arts history with DEI work. He then introduced guests Andrea Blackman and Razel Jones who are part of a wider Metro Government equity initiative to speak about their roles and how their work connects to Metro Arts.

Andrea Blackman (Metro Chief Diversity, Equity & Inclusion Officer) introduced her new position in the Finance Department and gave an overview of her role in the Metro Government with the primary goal of driving the city's developing equity mission. Her work covers both the internal and external. There will be a report of her initial forthcoming. She ended with an acknowledgement of past harms and moving towards correcting those harms.

Razel Jones (Metro Human Resources Workforce Diversity Manager), introduced his position in Human Resources and his current work examining what exists, revamping trainings, and offering additional HR resources. He is working with Andrea to pursue organizational DEI with consideration of departmental and outward facing DEI.

The Commission asked for clarification about how Board member interact with Metro HR and the Chief Diversity, Equity & Inclusion Officer. Razel Jones responded that he focuses on the internal and work-force related equity. Andrea Blackman responded that her work is more external facing, seeking advice and opportunities, and includes collaborating with Metro Boards and Commissions.

Commissioner Roberts thanked both guests for attending the CARE meeting. Andrea clarified that that would not be a one-time meeting and that they will be continuing to collaborate.

The Commission asked for clarification about reaching out directly. Both guests invited Commissioners to be in touch.

Chair Schmidt asked if there were any questions or discussion.

The Commission asked for clarification regarding the condition for an experienced/licensed clinician to participate in one of the projects regarding art and trauma and how that would impact the budget. Staff clarified that the cost of the clinician would come from the Thrive awardee, but that the condition was left open so as not to mandate a comparable cost. Additionally, staff will help the project coordinators find a suitable partner.

The Commission asked for clarification regarding how the religious contingencies were applied. Staff clarified that they were applied to any project that had religious content even with different types of treatment.

The Commission also asked about how COVID protocols are integrated into these projects. Staff clarified that reviewing COVID procedures was part of the scoring process and that all projects should comply with the Mayor's guidelines. It was also clarified that in the case circumstances change, staff is always open to working with projects to adapt.

The Commission requested that in the future staff provide the scoring rubric so that the Commission can understand the nuances of the review process.

The Commission asked for clarification about the living wage standard condition for one of the projects and how it will affect the project budget. Staff clarified that participants were originally getting the stipend, but that staff wanted to be sure that participants were being compensated at a living wage for the full number of hours they would need to participate.

The Commission asked for clarification about the process for if conditions are not met. Staff clarified that if a project declined the conditions then the allocations for their project would return to the Thrive funding pool.

A motion to approve the FY22 Thrive Cycle 1 Allocations was offered by Commissioner Cheek, Commissioner Angelico seconded, the motion passed.

2. Donelson Library Public Art Selection Panel

Van Maravalli gave an overview of the Donelson Library public art projects approved by Commission in August and presented the Committee with the proposed community selection panel.

Commissioner Alvis added that the Public Art Committee supports this proposed approach.

Chair Schmidt asked if there were any questions or discussion.

The Commission asked for clarification about the standard call timeline and whether is would allow enough time for applicants. Staff clarified that a month to a month and a half is typical with significant communications preparation. However, staff is also open to extending a deadline if there is a lower number of applicants or there are other concerns.

A motion to approve the Donelson Library Public Art Selection Panel was offered by Commissioner Alvis, Commissioner Roberts seconded, the motion passed.

3. Temporary Art Guidelines

Van Maravalli presented the proposed Temporary Art Guidelines for Metro Property created in partnership with several Metro departments. She reviewed the significant changes in this new document including streamlining the order of the document, clarified key contacts and departmental responsibilities, criteria for review and approval, and access to a variety of temporary art. The goal of the guidelines would be to encourage art that reflects the community, is safe, and is in relationship with their environment.

Chair Schmidt asked if there were any questions or discussion.

The Commission noted the use of "underrepresented" terminology and suggested specifically naming communities as they want to be named to avoid oppressive or offensive language. Staff thanked the Commission for the input and will incorporate into the updating process.

The Commission suggested that CARE could review these guidelines from an equity perspective.

The Commission asked for clarification about the funding of these programs. Staff clarified that these projects would be community generated, and Metro Arts would just be involved in the approval process because it is on Metro property.

At the request of the Commission, Metro Legal clarified that the Commission could adopt these guidelines as an interim process subject to CARE review. The Commission also proposed that guidelines and policy documents should be reviewed by CARE as a part of the process.

A motion to approve the Temporary Art Guidelines as an interim policy subject to review by CARE was offered by Commissioner Cheek, Commissioner Dow seconded, the motion passed.

The Commission requested that the document be sent to CARE and that they prioritize review within the next month or two.

4. Fairgrounds Public Art Concept

Atilio Murga reviewed the Fairgrounds Project details and presented the Commission with the first stage of the public art design concept. Blessing Hancock, the artist, will be developing additional elements to the concept through continued community engagement and with the help of her local mentee, Miriam Speyer.

Chair Schmidt asked if there were any questions or discussion.

A motion to approve Blessing Hancock's design for permanent public art at the Nashville Fairgrounds was offered by Commissioner Dow, Commissioner Ramos seconded, the motion passed.

5. 2021-2022 Officers and Committee Slate

Commissioner Alvis presented the Nominating Committee's recommendation for Officer's Slate: Jim Schmidt, Chair; Matia Powell, Vice Chair; and Will Cheek, Treasurer/Secretary.

Chair Schmidt also reviewed a recommendation from the Executive Committee to create a funding subcommittee made up of Commissioners and community members. There will be more details to come as this is developed.

Chair Schmidt asked if there were any questions or discussion.

A motion to approve the 2021-2022 Officers and Committee Slate was offered by Commissioner Alvis, Commissioner Dow seconded, the motion passed.

F. CARE Report

Chair Schmidt gave an update on the Human Resources investigation related to recent allegations. The Commission has been promised a thorough investigation and will decide next steps when the report is finished. The Commission will deal with the allegations seriously and with transparency.

Commissioner Roberts let the Commission know that CARE was working on a statement for the Commission, and it will be shared as part of the Committee's work alongside the Commission once they have gotten full input. She also updated the Commission on CARE's current work.

Chair Schmidt thanked the Commissioners on CARE and encouraged any Commissioner interested to ask about being involved. Additionally, he asked that Commissioners share any community member names that might be a good fit on the Committee.

Chair Schmidt recognized that a public comment related to this agenda item was submitted to the Commission. The letter was distributed, and Chair Schmidt encouraged Commissioners to review the comment.

G. Executive Director's Update

Caroline Vincent let the Commissioners know that there is an upcoming 1-day Crossroads training available to them if they are interested.
