Mr. Skoney reported that Live Nation currently has seven shows on sale, and they are on target

to host 13 shows this calendar year when they hosted eight last year. He said that they have a

slew of dates on hold for the first quarter of next year.

Mr. Skoney reviewed the events of the past two months and the upcoming events. He noted that

Real Country has 20 dates on hold and we are close to finalizing the contract with them. He said

that we are hosting Church of the City again this year and right behind them is The Belonging

Company Conference and that the two events will be sharing production elements.

Mr. Skoney stated that with regard to the financial report, he anticipates that we will end the year

\$25,000 in the black but that we would know more at the end of November.

There being no further business, the meeting adjourned at 9:20 a.m.
