include a mention of the NMA on the show as well as a 60 second reel that we can use on our

website to showcase the NMA.

Mr. Skoney reported that one of the things they wanted to do was a red carpet in front of the

NMA, but because of the bus station renovations that have temporary bus stops in front of the

building, we may have a challenge there.

Mr. McDaniel stated that he pitched the idea to integrate a walk-through of the museum during

the television shoot.

Ms. Hill reported that we will be working with BubbleUp to revamp our website.

Mr. Landers went on record to state that he works for BubbleUp, but he took the job after there

was a deal to have BubbleUp work with the NMA on the website.

Mr. Skoney stated that BubbleUp creates websites for LiveNation, and LiveNation is contracting

for and paying for our website redesign and hosting fee. He noted that we will maintain the

changes to website and provide the content. He stated that after the design is approved, any

additional changes will cost us \$125 an hour.

Mr. McDaniel asked Mr. Skoney to present the Manager's Report.

Mr. Skoney stated that Live Nation already has eight shows on the books, and we are only

halfway through the year. He said they have a lot of holds on for the fall.

Mr. Skoney reviewed the events slated for this summer and fall.

Mr. Skoney stated that he and Mr. McDaniel appeared before the Council to present the budget

for the next fiscal year. He said we are facing a break-even scenario this fiscal year.

Mr. Skoney stated that all of the materials for the concession bid and pouring rights bid have
been submitted to the Purchasing Department.
Mr. Skoney presented renderings for the restroom renovations for the Commission to review.
Mr. Skoney said that we have four Commission members with terms up for renewal on July 17 th .
Mr. Skoney stated that the next Commission meeting is on August 1 st .
