Mr. McKinney stated that Codes had posted a stop work order on the school and that a portable trailer had been brought onto the property by the school. He stated that classes are currently not being held at the location and requested that the permit be granted. The Board discussed that the stop work order does not mean the location is not a school, and that the order states the school is not licensed by the state. Mr. Abdulla stated that the school has filed all necessary forms and reports and that it is current with the state. He informed the Board that the school is open, but that they are using other facilities during the renovations. He also stated that the school has been in operation for 46 years. Following a general discussion, Ms. Cobb made the motion to deny the permit. The motion failed for lack of a second. Mr. McKinney stated that the school is currently not operating at this location, and that the school moved in after the market opened. Mr. Poole advised the Board that they should have more information before making a decision, such as the status of the school at the time this application was filed. - Executive Director's Report

Mr. McDonough briefly discussed several topics with the Board:

- Statistics for the month of September show revenue is on track compared to this time last year.
- The department's web page has been updated to include contact information for outside agencies, such as the Tennessee Department of Revenue and Secretary of State. Information on licensed beer wholesalers was also updated on the web page.
- Mr. McDonough informed the Board that the department has seen an increase in people coming to meet with Inspectors during Office Hours on Mondays.
- Board Rules
  - Mr. McDonough distributed to the Board copies of the Board Rules, which were reformatted to make them easier to read and understand. No changes were made to the rules, just to the format. He asked Board members to review the new format, to be discussed at the next meeting.
  - Mr. Taylor asked that Board members also review the rules to see what can be changed or eliminated.
- Any other issues
  - Beer distributors Mr. Joe Murphy and Mr. Martin Pruett discussed with the Board how the new policy of no longer granting permits and delaying issuance until all requirements are met has affected the distributors. They said that previously, applications which had been grant/delayed were flagged by the distributors, who knew to expect a permit to be issued soon. The new process of deferring applications, then issuing temporary permits once requirements are met has made it harder for them to keep up with new beer permits. They suggested that a notification be issued when new permits are issued. The Board discussed how notifications of new permits could be handled, but took no action at this time.

There being no further discussion, the meeting was adjourned at 12:55 p.m. until the next scheduled meeting set for October 25, 2017.
