a. Acts or simulated acts of sexual intercourse, masturbation, sodomy, bestiality, oral copulation, flagellation or any sexual acts which are prohibited by law;

b. Any person being touched, caressed or fondled on the breast, buttocks, anus or genitals;

c. Scenes wherein a person displays the vulva or the anus or the genitals; d. Scenes wherein artificial devices or inanimate objects are employed to depict, or drawings are employed to portray, any of the prohibited activities described above on or about 11/27/17)
