- c. Scenes wherein a person displays the vulva or the anus or the genitals; d. Scenes wherein artificial devices or inanimate objects are employed to depict, or drawings are

employed to portray, any of the prohibited activities described above on or about 11/27/17.

EXECUTIVE DIRECTOR'S REPORT:

- Mr. McDonough discussed the December total revenue and how the board is ahead of the projected totals.
- He gave an update on personal and business checks, with no returns on either as of this date.
- He mentioned, smart phones have come in and are in use. Possible use of technology in the Howard building to begin on Jan 17, will help reduce paper copies. Metro Council bill to accept online applications passed 2nd reading, and is scheduled to pass final on Tuesday Jan 23rd.
- He provided an update on the hiring of the new Office Support Specialist 1. 5
 people to interview; 1 person did not respond back to confirm an interview, 1
 withdrew, 1 person was offered the position after interviewing and is awaiting a
 background check.
- He mentioned, no new bills were introduced as of commencement of the January 9 state legislative session. He presented the new rule format for Rule 34 to convert into FAQ. Mr. Taylor mentioned, board members Ms. Jarmon and Mr. Davis were concerned about the rule lacking guidelines on how much a fine could be for each violation. Both board members mentioned were not present in today's board meeting. Mr. Spragens stated he likes the new rule change. Mr. Clements stated it would be best to wait for other board members before discussing the rule any further.
