However, you may file an appeal within 60 days of the date of the date of the entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

ⁱ Rule 29: Temporary permits should not be issued by the Executive Director to any applicant for any location that has a complaint by a beer inspector or law enforcement officer or a citation pending before the beer board. However, in the event of a complete change in ownership, when the former owner has relinquished all of his interest in the location at issue, a temporary permit may be granted to the new owner of a location if no violation is pending against him and if he meets all requirements for obtaining a permit. <u>February 24, 2016</u>

Rule 41: A permit shall not be issued by the Executive Director or the Metropolitan Beer Permit Board to any applicant that has a complaint by a beer inspector or law enforcement officer or a citation pending before the Metropolitan Beer Permit Board. The beer permit application shall be denied, and the applicant can reapply. <u>February 9, 2017</u>

Rule 29 and 41 have been combined into New rule 2.06

2.06 TEMPORARY PERMIT - PENDING COMPLAINT OR CITATION

A permit shall not be issued by the Executive Director or the Metropolitan Beer Permit Board to any applicant that has a pending citation or complaint by a beer inspector or law enforcement officer.

However, in the event of a complete change in ownership, when the former owner has relinquished all of his interest in the location at issue, a temporary permit may be granted to the new owner of a location if no violation is pending against him and if he meets all requirements for obtaining a permit.
