The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

Notes: Councilwoman Dowell spoke about 9 Bar/Lounge stated she felt like 9 bar/Lounge should meet with the community, Metro PD and have a safety plan as the area is considered high crime. She has received several phone calls about people leaving the parking lot intoxicated and is concerned other businesses in the area may leave due to problem caused by 9 Bar/Lounge.

Board member Jack Davis asked if 9 bar had met with MPD and formed a safety plan. Board member Jack Davis also said he felt we had went over this several times and 9 bar needs to comply with what has been asked of them.

Board member Kia Jarmon asked why the safety plan was not in hand when 9 Bar/Lounge came to the meeting. She said she asked to see it. 9 Bar/Lounge owner Cedaneo T. Lee said he has submitted it to the police.

Mr. David Young community representative spoke in opposition said he welcomed new business to the area but did not like that it was a nightclub and being classified as a restaurant.

Ms. Carol Joselin with Freeland Chevrolet has lived and worked in the area for over 20 years. She does not believe the business belongs in the area. She stated anything that happened after midnight was no good.

The 9 bar/Lounge owner Mr. Cedaneo T. Lee stated he had sent in the menu and submitted a security plan

to Officer Kendall Lee. Mr. Lee said he has cooperated in all ways and has tried to talk with everyone. It is impossible to address every safety issue but they try to keep it all safe. They have a security team that not only keeps their place secure but protects the parking lot for the other businesses.

Sonya Shirley, Manager 9 Bar/Lounge stated they have made several changes and have tried to communicate with the neighbors and the public. She stated they have two security teams in the parking lot not only to protect 9 bar/Lounge but the other businesses patrons also. She also stated she thought everything was ok with Councilwoman Dowell as she had been to the establishment several times and also held an event there.

Board member Telisha Cobb asked about their re-entry policy and Ms. Shirley stated they have to pay another 20.00 fee to go back in the building once they have exited. She also stated they are searched again before reentering

Sonya Shirley, Manager 9 Bar/Lounge also stated that in the last 1 1/2 years the police calls were not for their address it was problems in other businesses.

Board member Kia Jarmon stated she wants to see a security plan at the next meeting as we need 9 bar/ Lounge to do what they say they will do. We need to actually see the security plan not just talk about it.

Board member Jack stated we have heard this several times now and need to make a final decision. Board Chairman Brian Taylor stated we have to be careful telling business owners how to operate but we also need to make sure the safety concern is addressed. The board members also discussed why the beer permit is an issue when they already have a permit to serve liquor.

Mr. David Young stated he did not know why it changes but when beer is not served the police calls went down. Councilwoman Dowell stated she felt people drink more beer than liquor.

Kia asked if Councilwoman Dowell had been to the ABC board. She was told no they have not. The board deferred until next meeting and asked 9 Bar/Lounge to bring security plan in for the next meeting.
