# APPEAL OF DECISIONS

If you are not satisfied with a decision of the Metropolitan Beer Permit Board regarding your application or your hearing, you may appeal the decision to the Davidson County Chancery or Circuit Court pursuant to the requirements set forth in T.C.A. 57-5-108. The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

### **DISCUSSION:**

Attorney Will Cheek spoke to the board concerning Nissan Stadium – 7.08.140C Sale to Minor 12/15/19

Mr. Cheek said Nissan Stadium Legends had taken measures to address sales to minors.

Mr. Cheek presented Rule 4.08 pertaining to Sports Authority Facilities. Mr. Cheek informed the board that the maximum penalty they could assess against such facilities was a &2500 Civil penalty, unless the board could show a risk to public health, safety, and welfare existed.

#### **DIRECTORS REPORT**

Director McDonough updated the board on the revenue comparing the last 3 years to now. Director McDonough explained we had lost around 40,000 in revenue when we stopped doing dance permits and we still are ahead in revenue. He also Thanked Telisha Cobb and Terry Clements for serving on The Beer Board.
