Mr. McDonough explained that the delivery / curbside rules require an applicant to obtain an “on sale” or “on/off sale” permit prior to applying for a delivery / curbside permit. Further, a customer would have to place an order prior to the permit holder making a delivery. He explained that a person could not place an order, make payment, and take possession of the product simultaneously at an off-site location. Having deemed this explanation sufficient, Mr. Perlen made a motion to adopt new rule 5.01 and amended rules 3.04 and 3.05, all contingent upon Metro Council passing BL2020-455 later that evening. Ms. Spaulding then seconded the motion.

Mr. McDonough provided a status update on Beer Board revenue YTD. Mr. McDonough explained that the board had received just under \$2,000 less than this same time last fiscal year, which he stated was significant due to the current pandemic. Further, he stated that 217 permit holders had already paid their privilege tax this year. Mr. McDonough informed the board that the delivery / curbside permits would cost \$250 with an annual privilege tax fee of \$100.
