#### **MINUTES**

#### METROPOLITAN EMPLOYEE BENEFIT BOARD

#### September 1, 2020

The Metropolitan Employee Benefit Board met for their regularly scheduled meeting on Tuesday, September 1, 2020 via teleconference and was broadcast through the Metro Nashville Network, (MNN), on Nashville's Comcast Channel 3, AT&T UVerse Channel 99, and on the MNN Live Stream at approximately 9:33 a.m.

Chair Edna Jones called the meeting to order and stated that the first order of business will be a motion to determine under the Governor's Executive Order #16 that the meeting agenda constitutes essential business of this Board and meeting electronically is necessary to protect the health, safety and welfare of Tennesseans in light of the COVID-19 outbreak. This Executive Order expired June 30. The Governor extended that Order until August 29 and has been renewed through September 30th. B.R. Hall moved for approval. Stacey Rucker seconded and the Board approved without objection.

**A. MINUTES:** Chair Edna Jones called the meeting to order and said the first order of business was to determine if there were any amendments, corrections or questions of the minutes from the last regular meeting held on August 4, 2020. With no corrections, nothing further was noted and Christine Bradley moved for approval. Stacey Rucker seconded and the Board approved

without objection.

#### **B. APPEAL ANNOUNCEMENT:**

Christina Hickey announced the process and timeframe for appealing a decision made by this Board.

### C. DISABILITY PENSIONS: (new requests, reexaminations, return to work and social security referrals)

The terms of the approval or extension of the items listed in the motions are specifically stated in these minutes.

Dr. Gill Wright, Civil Service Medical Examiner, (CSME), and Claire Cobb, CSME Assistant, reviewed the disability pensions with the Board.

Dr. Gill Wright reported to the Board that he recommends approval of the disability pension new requests, items 1 through 4, for the length of time as recommended. Stacey Rucker moved for approval of the recommendation to approve the disability pension new requests, items 1 through 4 for the length of time as recommended. Christine Bradley seconded and the Board approved without objection.

Dr. Gill Wright reported to the Board that additional information has been supplied regarding a surgery later in the month and there are no restrictions. He stated that he recommends denial of the disability pension new request, item 5. He also stated that if the Board chooses to approve this request he would recommend no reexam as she will convert to a service pension in December. Stacey Rucker moved for approval of the recommendation to approve the disability pension new request, item 5 for the length of time as recommended. Shannon Hall seconded.

After some discussion of the additional medical information regarding the surgery, there being no restrictions, and that as of today she is not disabled there was discussion of deferring this request. The makers of the motion were in agreement to defer this disability pension new request item 5 for one month. A vote was taken on the motion to defer the disability pension new request item 5 for one month and the Board approved without objection.

#### C. DISABILITY PENSIONS: (new requests, reexaminations, return to work and social security referrals)

The applicant addressed the Board regarding her condition, medications and side effects of those medications.

Dr. Gill Wright reported to the Board that he recommends denial of the disability pension new request, item 6 based on the medical record. He stated that her condition is at baseline and there are no restrictions.

After some discussion of her condition, the side effects from the medications and intermittent FMLA, Todd Henry moved for approval of the disability pension new request item 6 for three months. Stacey Rucker seconded and the Board approved without objection.

Dr. Gill Wright reported to the Board that he recommends denial of the disability pension new request, item 7 as there is nothing in the medical record to support the request. Christine Bradley moved for approval of the recommendation to deny the disability pension new request, item 7. Tom Curtis seconded.

There was some discussion regarding medications they may be taking and how it may have an effect on someone that operates heavy machinery.

Dr. Gill Wright stated that the medical record does not show the medications are causing any problems.

A vote was taken on the motion to deny the disability pension new request item 7 and the Board approved without objection.

Dr. Gill Wright reported to the Board that he recommends approval for continuing the disability pension reexaminations, items 8 and 9 for the length of time as recommended. Todd Henry moved for approval of the recommendation to continue the disability pension reexaminations, items 8 and 9 for the length of time as recommended. Tom Curtis seconded and the Board approved without objection.

Dr. Gill Wright reported to the Board that on items 10 through 12, he requests a deferral for two months. Stacey Rucker moved for approval of the request to defer items 10 through 12 for two months. Harold Finch seconded and the Board approved without objection.
