MINUTES

METROPOLITAN EMPLOYEE BENEFIT BOARD

October 6, 2020

The Metropolitan Employee Benefit Board met for their regularly scheduled meeting on Tuesday, October 6, 2020 via teleconference and was broadcast through the Metro Nashville Network, (MNN), on Nashville's Comcast Channel 3, AT&T UVerse Channel 99, and on the MNN Live Stream at approximately 9:42 a.m.

Chair Edna Jones called the meeting to order and stated that the first order of business will be a motion to determine under the Governor's Executive Order #16 that the meeting agenda constitutes essential business of this Board and meeting electronically is necessary to protect the health, safety and welfare of Tennesseans in light of the COVID-19 outbreak. This Executive Order expired June 30. The Governor extended that Order until August 29th and was first renewed through September 30th and now through October 28th. B.R. Hall moved for approval. Stacey Rucker seconded and the Board approved without objection.
