Human Resources Director, Veronica T. Frazier, submits the following for the Commission's consideration and appropriate action:

(1: Review of Agreed Order – Timothy Tawater, Fire Department – Demotion

Mr. Tawater's Legal Counsel Dewey Branstetter and Metro Attorney Jennifer Crim, representing the Fire Department, were present before the Commission to discuss the Agreed Order.

MOTION: After some discussion, Commissioner Link moved to uphold the Administrative Law Judge's Agreed Order. Seconded by Commissioner North, and the Commission approved without objection.

(2: Appeal of Medical Disqualification: KD, Applicant for Police Officer Trainee

Applicant KD and Nurse Practitioner Ashley Lewis, representing Civil Service Medical Examiner Dr. Matthew Hine, were present before the Commission to discuss the appeal.

MOTION: After some discussion, Vice-Chairman Corbitt moved to approve the appeal. Seconded by Commissioner North, and the Commission approved without objection.

(3: Request to Extend the Police Captain Promotional Register for six months

Human Resources Analyst Seth Waltenbaugh and Human Resources Manager Sue Bibb were present before the Commission to discuss the request.

MOTION: After some discussion, Commissioner Link moved to extend the register an additional six months. Seconded by Vice-Chairman Corbitt, and the Commission approved without objection.

(4: Memorandum of Understanding (MOU) with Nashville Firefighters and Fire Service Employees Association, Local 140 (IAFF)

Human Resources Assistant Director Michael Taylor and IAFF President Mark Young were present before the Commission to discuss extending the MOU agreement through December 31, 2016.

MOTION: After some discussion, Vice-Chairman Corbitt moved to approve the MOU Extension Agreement. Seconded by Commissioner North, and the Commission approved without objection.

(5: Administrative Law Judge Hearing Calendar

Chairman Farmer asked if the report had been submitted to the Administrative Law Judges. Ms. Tullos replied yes. The calendar refers to appeals submitted by Metro employees. As changes occur, updates are made each month in conjunction with the assigned Attorneys at Metro Legal. A copy is then forwarded to the State Administrative Procedures Division wherein the State provides a copy for each Judge to evaluate their case.

(6: Human Resources Updates

Human Resources Director Veronica Frazier announced Human Resources has, in consultation with Deloitte, completed a new performance evaluation management system. HR Summer Intern Josh Bowman researched materials and worked on the project. Josh is getting his Master's Degree from Western Kentucky University in Industrial Organization and completing his thesis on Performance Evaluations, and we were lucky to have him.

Human Resources Benefits staff have completed work on an employee, self-service Pension Calculator, which is now available on the website. Pension estimates will soon be mailed to Metro Employees.

The Veterans Service Officer received accreditation with the National Association of County Veterans Service Officers. At next month's meeting, she will present an update on Veterans Service projects and accomplishments.

Over the past several months, Human Resources Staff Member Tam Gordon has partnered with Metro Departments and the Metro Nashville Network, formerly Metro 3, to complete recruitment videos for Metro Departments. Emergency Communications Center Director Michelle Donegan and Tam Gordon will present the recruitment video for ECC.
