As changes occur, updates are made each month in conjunction with the assigned Attorneys at Metro Legal. A copy is then forwarded to the State Administrative Procedures Division wherein the State provides a copy for each Judge to evaluate their case.

## (13: Human Resources Updates

Human Resources would like to request a public hearing following the regularly-scheduled Civil Service meeting on May 9, 2017 for consideration of proposed changes to the pay plan.

The Mayor's Office has nominated Commissioner Sanders for reappointment to the Civil Service Commission. The Metropolitan Council will act on her reappointment at its meeting on Tuesday, April 18, 2017.

On Friday, March 24, HR staff met with students from Fisk University to promote the Mayor's Opportunity NOW employment program for youth ages 14 to 24.

As part of the Mayor's Opportunity NOW employment program, Human Resources will have 5 students working on a video recruitment project this summer.
