(3: Job Description Revisions

- 1st MOTION: After some discussion, Commissioner North moved to approve the job description changes on Correctional Officer 2. Seconded by Commissioner Sanders, and the Commission approved without objection.
- 2nd MOTION: After some discussion, Commissioner Sanders moved to approve the job description changes on Correctional Officer Sergeant. Seconded by Commissioner North, and the Commission approved without objection.
- 3rd MOTION: After some discussion, Commissioner North moved to approve the job description changes on Correctional Officer Lieutenant. Seconded by Commissioner Sanders, and the Commission approved without objection.

(4: Appeal of Medical Disqualification: RE, Applicant for Police Officer Trainee

Applicant RE, Human Resources Analyst Seth Waltenbaugh, and Civil Service Medical Examiner Dr. Gill Wright, were present before the Commission to discuss the appeal.

(7: Civil Service By-Law changes request

Human Resources Analyst Seth Waltenbaugh was present before the Commission to discuss an update to Section 10 of the Civil Service By-Laws. The recently adopted BL2017-612 amends Title 2 of the Metro Code pertaining to the submission and formatting of agendas and minutes by Metro boards and commissions on Nashville.gov.

Consistent with the Ordinance, Civil Service Commission agendas and minutes are currently posted promptly to Nashville.gov, with web consistency and in a searchable, electronic format; updating the Civil Service By-Laws to include this wording ensures full compliance with the Ordinance.

MOTION: After some discussion, Commissioner North moved to approve the Civil Service By-Law changes request. Seconded by Commissioner Sanders, and the Commission approved without objection.

(8: Civil Service Policy 5.10-II Compensation on Open Ranges changes request

Human Resources Analyst Seth Waltenbaugh was present before the Commission to discuss the proposed policy changes related to the proposed pay plan.

MOTION: After some discussion, Vice-Chairman Corbitt moved to approve the policy changes. Seconded by Commissioner North, and the Commission approved without objection.

(9: Appointment of Shannon B. Hall as Human Resources Director

Shannon B. Hall was present before the Commission.

MOTION: After some discussion, Commissioner North moved to appoint Shannon B. Hall. Seconded by Commissioner Sanders, and the Commission approved without objection.

(10: Administrative Law Judge Hearing Calendar

Chairman Farmer asked if the report had been submitted to the Administrative Law Judges. Ms. Tullos replied yes. The calendar refers to appeals submitted by Metro employees. As changes occur, updates are made each month in conjunction with the assigned Attorneys at Metro Legal. A copy is then forwarded to the State Administrative Procedures Division wherein the State provides a copy for each Judge to evaluate their case.

(11: Human Resources Updates

On May 10, Human Resources staff participated in the Opportunity NOW and American Job Center job fair at the Southeast Community Center to promote the Mayor's Opportunity NOW employment program for youth ages 14 to 24.

At a job fair on May 18, HR staff focused on the under-employed in an effort to help those in minimum wage jobs or positions without the potential for advancement get information on positions with growth opportunities.

Human Resources hosted an HR Coordinators Meeting on Tuesday, May 23 to discuss New Civil Service Rules and Policies, the Pay Plan, and Open Range Plan.

Human Resources Interim Director John Kennedy thanked the Civil Service Commission for his appointment as Human Resources Interim Director, and the Civil Service Commission commended him on fulfilling that role.
