GENERAL SERVICES

- (1: Director Nancy Whittemore requests an Administrative Leave extension for a General Services department employee which will exceed forty-five (45) days

Assistant Director Velvet Hunter and Human Resources Analyst Aaron Shelton were present before the Commission to discuss the request.

MOTION: After some discussion, Commissioner North moved to approve the request for Administrative Leave. Seconded by Commissioner Link, and the Commission approved without objection.

HUMAN RESOURCES

Human Resources Director, Shannon B. Hall, submits the following for the Commission’s consideration and appropriate action:

- (2: Review of Initial Order – Wendy Johnson, Water – Suspension/Dismissal

Metro Legal Attorney Tara Ladd, representing Water Services, was present before the Commission to discuss the appeal. Ms. Johnson and her representation were duly notified of the meeting, but not present for the review.

MOTION: After some discussion, Commissioner North moved to approve the Initial Order and uphold the dismissal. Seconded by Commissioner Sanders, and the Commission approved without objection.

(3: Review of Order of Dismissal – Delba Graham, Sheriff - Dismissal

Cyndi Gross, representing Davidson County Sheriff's Office, was present before the Commission to discuss the Agreed Order of Dismissal. Mr. Graham self-represented and was duly notified of the meeting, but was not present for the review.

MOTION: After some discussion, Commissioner Link moved to approve the Order of Dismissal. Seconded by Commissioner North, and the Commission approved without objection.

(4: Review of Initial Order – Michael Dudley, Police – Suspension/Demotion

Mr. Dudley, his representation Kim Gilleland, and Cyndi Gross, representing the Police Department, were present before the Commission to discuss the Initial Order.

MOTION: After some discussion, Commissioner Sanders moved to approve the Initial Order and uphold the demotion. Seconded by Vice-Chairman Corbitt, and the Commission approved without objection.

(5: Revisions to the Civil Service Rules and Policies

Human Resources Administrator Mary Emigh was present before the Commission to discuss the revisions to Civil Service Rules Sections 2.2, 2.4, 2.10, 2.13, and 5.7 and associated Policies 2.6-I, 2.6-II, 2.7-I, 2.7-II, 2.7-III, 2.10 C-I, 2.12, and 2.12-I.

Commissioner Link verified the changes had been reviewed by the employee representative groups. Ms. Emigh confirmed and further stated they had also been reviewed by Metro Legal, all of which took place prior to the April Civil Service Commission Meeting.

(6: Report on Benefit Board Election Results (Metro Charter 13.03) for Retired Employee Representative
