

**METROPOLITAN NASHVILLE-DAVIDSON COUNTY
TRANSPORTATION LICENSING COMMISSION**

Minutes

July 28, 2016

The Metropolitan Nashville-Davidson County Transportation Commission (TLC) met in regular session on this date in the Jury Assembly Room of the Historic Courthouse. Present were Chairman Sal Hernandez, Vice Chair Tom Turner and Commissioners Freddie Carr, Pat McNally Rhonda Marko and Curt Wallen (6). Also present were Metro Legal Advisers Tara Ladd Costonis as well as TLC staff members Lisa Steelman and Billy Fields.

The Chair called the meeting to order at 1:30 p.m. then led the Pledge of Allegiance followed by a reading of the Notice of Appeal Statement which outlined the right of appeal for TLC decisions.

Commissioner Wallen with a second from Commissioner McNally moved to approve the previous meeting minutes.
