Taxicab Driver Applications

After some discussion, Commissioner McNally, with a second from Commissioner Patel, moved to approve.

Horse and Carriage

Elizabeth Keith of Keith Carriage appeared with her representative Gary Blackburn, to request permission for Keith Carriage to operate in the downtown area. Ms. Costonis described the process by which a company is given permission to operate and that the Certificates of Public Necessity and Convenience can have limits or special provisions. At present, she explained that Ms. Keith's certificate was limited and could not operate on the downtown route. After some discussion, Commissioner McNally, with a second from Commissioner Patel, moved the current restrictions on this Certificate be amended and removed which restrict operations to Centennial Park only and that Keith Carriage be allowed to operate in the downtown area on Friday through Sunday.
