The chair closed the public hearing. Director Fields explained that the first action the TLC should take is to consider whether or not additional Certificates or permits for taxicabs are needed. If the TLC decides more permits are necessary then the next action would be to determine how many additional vehicle permits were necessary. Commissioner Patel, with a second from Vice Chair Turner, moved that proof was presented that additional Certificates and vehicle permits were needed.

Vice Chair Turner moved, with a second from Commissioner Marko, that the additional permits should be approved and that a minimum of 10 percent of those issues should be ADA wheelchair compliant.

Commissioner Marko moved, with a second from Vice Chair Turner, to approve 35 permits each for Magic Taxi, NashVegas Cab and Pink Taxi with 10 percent being ADA compliant.

(Total permitted 35 each plus 10 percent ADA)

Vice Chairman Turner moved to approved 80 permits for Taxi USA with 10 percent being ADA compliant. There was no second.

Commissioner Wallen moved, with a second from Commissioner McNally, to approve 65 permits for Taxi USA with 10 percent being ADA compliant.

(Total permitted 285 plus 10 percent ADA.)

Commissioner Patel, with a second from Commissioner McNally, moved to approve 25 additional permits for Kwik Cab with 10 percent being ADA compliant.

Commissioner McNally, with a second from Commissioner Wallen, moved to approve 40 additional permits for Yellow Cab with 10 percent being ADA compliant.

Vice Chair Turner, with a second from Commissioner McNally, moved to approve 20 additional permits for Green Cab with 10 percent being ADA compliant.

(Total permitted 55 plus 10 percent ADA)

Vice Chair Turner, with a second from Commissioner Patel, moved to approve 20 additional permits for United Taxi with 10 percent being ADA compliant.

ACTION:

Approved 5-1.

(Total permitted 90 plus 10 percent ADA)

Commissioner McNally moved, with a second from Commissioner Patel, moved to approve 25 additional permits for Checker Cab with 10 percent being ADA compliant.

ACTION:

Approved 6-0.

(Total permitted 130 plus 10 percent ADA)

Executive Secretary's note: The total of permitted vehicles is 1125 (including today's decision) as well as up to 10 percent ADA compliant vehicles per certificate. Each company must have 10 percent of the permits issued today in services as ADA compliant vehicles for wheelchairs. American Music City Taxi did not apply today, but has 95 permitted vehicles plus up to 10 percent of this total ADA Wheelchair compliant vehicles.

Commissioner McNally moved, with a second from Commissioner Turner, to have half of the newly approved taxicabs vehicles must be in service by April 1 and the second half plus all ADA taxicabs must be in service by June 1.
