## Other Passenger Vehicles for Hire

New Company Applications

Director Fields presented an application for Certificate of Public Convenience and Necessity to operate as Other Passenger Vehicle for Hire from Absolute Limousine dba A1 Brentwood Franklin. Commissioner Marko, with a second from Commissioner Patel, moved to approve all nine applications.

OPVH Driver Application

Director Fields presented an application from Ali Hasan to be an OPHV driver. Commissioner Marko, with a second from Commissioner Jordon, moved to approved.

#### **Taxicabs**

Director Fields presented an application from Darren L. Dave to be a taxicab driver, but Mr. Dave was not present. Commissioner Wallen, with a second from Commissioner Patel, moved to defer action until November.

## **Public Hearing**

The Chair stated the purpose of the public hearing as consider Legislation to regulate the commercial use of pedicab and peddle carriage vehicles within certain portions of Nashville and Davidson County and opened the public hearing. No one from the public asked to speak so the Chair closed the public hearing.

After some discussion, Mr. McNally, with a second form Commissioner Patel, moved to recommend the legislation to the Metropolitan Council and consider the following additions:

- Provision allowing the TLC to adopt rules regarding operations during inclement weather
- Revised language regarding placement of mirrors
- Review language related to alcoholic beverages while in operation
- Revise recitals with respect to the number of visitors to the Metropolitan government area and their economic impact.

No action was required at this time.
