### Minutes

#### June 22, 2017

The Chair called the meeting to order at 1:46 p.m. then led the Pledge of Allegiance followed by a reading of the Notice of Appeal Statement which outlined the right of appeal for TLC decisions.

Vice Chair Turner with a second from Commissioner Marko moved to approve the previous meeting minutes.

### Wrecker and Towing Services

Andre Rivers of Advanced Towing filed a complaint against Justin Hart regarding his conduct as a wrecker driver. Mr. Rivers explained the complaint to the TLC. Mr. Hart was not present. Vice Chairman Turner with a second from Commissioner Carr moved to suspend Mr. Hart's wrecker driver permit until he appears before the TLC.

William Clarke Troupe applied to be a driver. After some discussion, Commissioner Marko with a second from Commissioner Carr moved to approve.

Carl Newman applied to be a driver, but failed to fully disclose his background. Commissioner Marko with a second from Vice Chair Turner moved to approve.

John Roberts Jr. applied to be a driver, but failed to appear. Vice Chair Turner with a second from Commissioner Carr moved to defer until July meeting.

ACTION: Approved 3-0

#### Public Hearing on Proposed Wrecker Ordinance Change

Director Fields explained that there has been confusion related to when a vehicle being towed is released prior to its removal from the towing request site. He explained that there had been situation where there was some level of confusion on who was the operator of the vehicle and to whom the vehicle can be released once it is on the hook, but has not been transported. Director Fields requested that the TLC recommend to the Metropolitan Council appropriate language to help make the conditions of the vehicle release before it is moved more clear.

The Chair opened the Public Hearing opened the hearing at 2:11 p.m. Jim Mitchell was present to speak. The Chair closed the hearing at 2:15 p.m. After some discussion, Vice Chair Turner with a second from Commissioner Marko moved to make this recommendation to the Council.
