- 2. **26-2 Ellington Agricultural Center to be moved to Crievewood Baptist Church** (Temporary change due to construction). All voters will be sent a notice of the temporary move.
- 3. **34-4 Forest Hills Baptist Church to be moved to Forest Hills City Hall** (Permanent move due to many programs being held at the church). All voters will be sent a notice of this permanent move.

Determination of voter eligibility

A voter submitted three voter registration forms where two of them were marked "no" regarding the U.S. citizen question and one marked "yes" she is a U.S citizen. DCEC data entry error made her active in our system and the voter voted in the August and November elections of 2016.
