#### DAVIDSON COUNTY ELECTION COMMISSION

The Davidson County Election Commission (DCEC) met on August 15, 2018 at 3:00 p.m. in the Green Hills Conference Room at Metro Southeast. Commissioners Jim DeLanis, Jesse Neil, AJ Starling, Emily Reynolds and Tricia Herzfeld were present. DCEC staff members present included: Administrator of Elections (AOE) Jeff Roberts, Joan Nixon, John Hite, Courtney Mott, Carlatina Hampton and Kelley Harrison. Also in attendance were Nicki Eke and Lora Fox, of the Metropolitan Department of Law.

Chairman DeLanis convened the meeting.

#### **Action on petition regarding Citizens Review Board**

Chairman DeLanis addressed questions to the DCEC staff regarding the Citizens Review Board petitions. Attorneys, David Raybin and Austin McMullen for the Fraternal Order of Police (FOP) were allotted five (5) minutes to speak regarding the number of signatures being disqualified and the referendum not be placed on the November 6<sup>th</sup> ballot.

Attorney, Jamie Hollin was allotted five (5) minutes to speak on the behalf of the Citizens Review Board. Discussion ensued among the board.

Chairman DeLanis referenced proposed Charter Amendment C; Resolution RS201A-1314 (Ranked Choice Voting) which he feels may affect the DCEC in a practical way.

Discussion ensued among the Commission.

Motion stated: Commissioner Herzfeld made a motion for AOE Roberts to consult with staff and send a letter to Metro Council outlining the impact Ranked Choice Voting would have on the DCEC and emphasize the neutral position of the Commission.
