# **Executive Board Meeting Minutes**

## **MHRC Executive Board Agenda**

- I. CALL TO ORDER: MHRC Vice Chair, Janice Rodriguez
  This meeting was called to order at 3:11p.
- II. NEW BUSINESS (30 Minutes)
  - CBC Hildreth proposed a focus on education to enlighten ourselves as Commissioners with an agenda of topics to cover during the year.
  - Commissioner Rodriguez asked if she can apprise individual Commissioners about our respective work. CBC Hildreth said yes, and suggested Commissioners consider using an infographic. E.D. Fowler-Green said that there is no policy preventing such.
  - Commissioner Poster asked how do we position ourselves next year so that our work is more widely known and understood—particularly among decision makers?

In response to Commissioner Poster's query, CBC Hildreth invited Commissioners to look at how to make the work of civic engagement effective.

- E.D. Fowler-Green reviewed bylaws and Executive Board roles and responsibilities
- Recommendation regarding Executive Compensation, Open Range Increase (ACTION NEEDED)

After this item was discussed and reviewed, Commissioner Poster recommended a 4% increase for all staff, including E.D. Fowler-Green.

Commissioner Rodriguez motioned to increase E.D. Fowler-Green's salary by the recommended 2%; Commissioner Richmond seconded. All were in favor, there was no opposition; motion carried.

CBC Hildreth asked Executive Committee if they'd like to recommend adopting the Open Range increase to the Full Commission. Entire Committee agreed to do so.

- CBC Hildreth asked if Executive Committee had reviewed the recommendations from the DOJ. She requested that Commissioners carve out time to asses and offer next steps. She specifically asked Commissioner Richmond to make recommendations in her capacity as the Chair of the Due Process Committee.
- E.D. Hildreth said that she is proud of this Commission and our participation in civic engagement
