- E.D. Fowler-Green asked if she should prepare a narrative. CBC Hildreth requested bullet points or deeper insight of evaluation with specifics. Comm. Poster requests portfolio success from the past year or so.
- Comm. Poster asked if commentary should be included. CBC Hildreth said yes—but after initial evaluations. Commissioners can send remarks.
