



Metro Human Relations Commission Full Commission Meeting Minutes

The mission of the Metro Human Relations Commission is to protect and promote the personal dignity, peace, safety, security, health, and general welfare of all people in Nashville and Davidson County.

I. CALL TO ORDER: MHRC Board Chair, Dr. Janice Rodriguez

The meeting was called to order at 4:04 p. m.

II. CONFIRM QUOROM

A quorum was achieved in the beginning of the meeting.

III. REVIEW AND APPROVAL OF MINUTES

Comm. Miller moved to approve the Minutes. Comm. Richmond seconded. Minutes were approved.

IV. FINANCIAL REPORT: CBC Janice Rodriguez

Commissioners reviewed the financial report included in the meeting packet.

- There seems to have been an accounting snafu with Metro Payment Services:
 - -- Metro Payment Services recently informed us that over the past three years, we were double-billed on a number of things that were not properly reconciled. This means that we have an additional \$9,860 in our budget.
 - -- We are going to review those sponsorships that we had previously determined we were not going to do, so we may be reinstating some sponsorships.

V. **NEW BUSINESS**: Mel Fowler-Green, Executive Director

- Note: On our internal list of Commissioners, Chuck Yezbak's email address is wrong. We will
 revise.
- Review of Officer roles and election process (description of all officer roles detailed in packet).

- Elections will take place in June. Appointments are for a year. Commissioners may serve for an additional year in the same role or in another capacity.
- Volunteers for Nominating Committee: Lethia Mann (Chair), Marisa Richmond, and Irwin Venick.
- Approval for out-of-county training: Our team does a full day Equity training at the Center for Nonprofit Management. The United Way in Williamson and Rutherford County are doing trainings on collective impact and equity. They have asked us to do that for them.

OLD NEW BUSINESS: Mel Fowler-Green, Executive Director

- Mayor has announced his proposed budget, which includes restoration of the required savings.
- The Commission will receive a small increase to cover rent.
- We requested an additional employee, but that has not been included in the Mayor's budget.
- Mayor's budget also includes a cost of living increase, as well as funds for open range increases.
- Open range increase decisions happen in July.
- Council hearing on the budget is May 13th, 5:45 pm.

VI. COMMITTEE REPORT

There were no Committee Reports.

VII. **DIRECTOR'S REPORT**: Mel Fowler-Green, Executive Director

- The Executive Committee should meet before July to do the annual review of Executive Director..
- IncluCivics report is a diversity report for Metro employees. Does Metro workforce reflect the
 population of Nashville? Mayor Karl Dean created a diversity Advisory Committee. There was
 a Chief Diversity Officer position in the Mayor's office. The report was also replicated for
 MNPS.
 - Up until a few years ago, the demographics information of Metro employees was not published on a data portal. It had to be requested through an open data request.
 - o The online IncluCivics platform has been updated by coders for Nashville
- The Commission discussed ways in which our office might record interactions/calls/feedback to measure the impact of our work.

PUBLIC COMMENT

Vanessa Lazon: Followed up with Ashford Hughes and provided the following updates:

- Comm. Venick asked for clarification about whether Barnes Fund money was used to purchase the Morris Memorial building (i.e., the National Baptist Convention's Sunday School Publishing Board offices.). The answer is "no".
- Comm. Richmond asked about health benefits for transgender employees: Metro plans cover transgender related services. The Employee Benefit Board in Nov 2016 decided that it doesn't cover surgery for sex reassignment, but it covers other services.
- Comm. Davis: Is there a way for this body to make recommendations to the Employee Benefit Board?
- ED Fowler-Green: We met with the LGBTQ liaison at the Mayor's office, and we understand that the Mayor's office will assist us in in pursuing this by the end of this year.

- Comm. Venick suggested the creation of a task force to research options for addressing changes brought by Tennessee Pub. Ch. 698, and to make recommendations to the full Commission. This suggestion will be addressed at the next meeting.

Appeal of Decisions From the Metro Human Relations Commission

If you are not satisfied with a decision of the Metropolitan Human Relations Commission, you may appeal the decision by petitioning for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Human Relations Commission's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.
