The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

Chairman Taylor read the complaints and their corresponding recommended penalty. Mr. Perlen made a motion to approve the staff recommended civil penalties. That motion was then seconded by Ms. Jarmon. The board then voted unanimously to approve the motion and corresponding recommended civil penalties.

The permit holder plead guilty in this matter. Following an operation by MNPD, it was determined that the permit holder was knowingly buying and selling stolen merchandise. The detective overseeing the investigation stated that a confidential informant made it clear to the permit holder that the items were stolen, and the permit holder later provided a list of items they would be willing to purchase from the informant. The permit holder has admitted their involvement in the case and apologized for the illegal activity. The permit holder stated that this business is their sole source of income and revocation of their beer permit would decimate their family's financial stability. The detective noted for the board that he believed the apology was sincere and he believed that granting another opportunity would be appropriate in this case. Further, there was no padlock order initiated against the permit holder.

Following the testimony and questions by board members, Mr. Bellamy made a motion to issue a \$10,000 civil penalty, require the permit holder to attend training by Beer Board staff, provide a corrective action plan to Beer Board staff within sixty (60) days, and serve probation for twenty-four (24) months. Or, the permit holder could serve a twenty-four (24) month suspension. That motion was then seconded by Ms. Spaulding. The board then voted unanimously to approve Mr. Bellamy's motion.
