

METROPOLITAN HISTORICAL COMMISSION (MHC) MINUTES

May 16, 2016

The Metropolitan Historical Commission held its regular meeting on May 16, 2016, in the conference room of the Historical Commission office at 3000 Granny White Pike, with Commission Chair Jim Forkum presiding.

Chair Jim Forkum called the meeting to order.

APPROVAL OF MINUTES - Jim Forkum

Chair Forkum asked if there were any amendments or questions regarding the minutes from the April 2016 meeting. Alex Buchanan mentioned that Lynn Maddox was marked as present but she had not attended. Bob Allen made a motion to approve the minutes as corrected. Dr. Bill McKee seconded and the commission voted to approve them unanimously.

BUDGET HEARING REPORT – Jim Forkum

Chair Forkum mentioned that MHC's Council budget hearing went very well. Forkum thanked the commissioners who had attended the hearing for their support. During the hearing, several council members had mentioned that they would like to add funds for a half-time staff person to the Historical Commission's budget, and that they knew the need was justified due to the number of properties under review by the MHZC. Other council members had questions about funds for historic markers.

PRESERVATION AWARDS RECAP - Scarlett Miles

Ms. Miles mentioned that the Awards program went very well. Several council members attended. Recipients of the Architectural Awards were very appreciative. The program was recorded by the Metro Nashville Network and is available for viewing on their website. Lots of pictures were taken and are available for anyone wishing to see them.

Chair Forkum thanked Scarlett and the rest of the MHC staff for their work on the program and said it was one of the best he could remember. He also commended Tim Walker for his presentation at the Awards program and the Council budget hearing and said that Tim always represents the department very well.

DIRECTOR'S REPORT - none given

HISTORIC ZONING REPORT - Robin Zeigler

A new commissioner has joined the Historic Zoning Commission. Cyril Stewart will be the representative architect. Brian Tibbs has joined the Planning Commission and will continue to serve the MHZC as the Planning Commission rep, replacing Hunter Gee, who was not reappointed to the Planning Commission.

Jim Forkum read a letter from former councilman Phil Claiborne on behalf of Friends of Two Rivers Mansion, thanking the commission for their recent recognition and Commissioners' award in the 2016 Preservation Awards program.

Clay Bailey mentioned that the Memorial Day Dash 5K race is coming up on May 30. This year's run is dedicated in honor and memory of Mitchell Mielnik, who was a frequent volunteer and participated in the race several times over the years.

Clay Bailey also mentioned that Metro Parks would be hosting a series of public meetings for input on a Master Plan for Metro Parks, and that someone from the commission and/or staff should be there to encourage preservation of historic sites within the parks.

Dr. Carole Bucy, County Historian, mentioned that the Nashville Encyclopedia project has been put on hold for now, because no funds were allocated for it in the FY17 budget.

With no further business to discuss, the meeting was adjourned.

Establishing Photographic Record of Old Cemeteries to Aid Family Researchers

Author has spent past 2.5 years (since retirement) working on Ancestry Annals for both himself and his wife. Ancestry Annals are just the opposite of a 'family tree' - Pick yourself as the starting point and document EACH set of your grandparents back through time. Thus far, author has documented ~75 sets of grandparents, 200+ photographs, and ~5,000 descendants for each Ancestry Annals document - each document is now 350+ pages and growing.

One problem author encountered was that at least 21 of his wife's grandparents (as well as other relatives) are buried in 3 cemeteries in Green County, AL. The quickest way to ensuring identification of all known burials in those cemeteries was to photograph the individual tombstones. During one February 2016 weekend, author photographed 840 tombstones in 3 cemeteries there. The worth of these photographs to support further research was immediately obvious. For one thing, he could now work on transcription of degraded tombstone inscriptions at his own pace.

In March 2016, Bob Allen suggested that author undertake a similar photographic effort for historic cemeteries in the Bellevue area. Biggest problems encountered thus far include:

- 1) Actual Location of the site Author had to ask directions to locate most sites. GPS Lat/Long and Accurate Location Information will cure this problem. This issue MUST be addressed.
- 2) Many of these sites are posted You have to be aggressive Thus far, no denials on photographing site
- 3) Legal Description of Site May be difficult to determine These family burial sites were 'grandfathered'
- 4) No one website includes all of the published burial information Author compiled Info from multiple sources

Author's emphasis is on individual burials rather than on individual (& legible) tombstones - to include identification of those individuals whose tombstone is eroded or missing.

Author's Objectives

Maximize Value of Cemetery Information to Individual Family Researcher

- 1. Identify Historical Burial Plots in Bellevue Area
 - Enable Additions/Corrections as New Ones are Identified
- 2. Identify Total Number of Known Burials with Earliest & Latest Burial
- 3. Identify Name/Address of Current Owner (as of 2016)
- 4. Identify Individual Who Donated Property for Cemetery and WHEN
 - Intended to assist family researchers in identifying WHERE their ancestors lived
- 5. Provide Accurate Location (i.e., GPS Lat/Long) plus Instructions on Driving to Site
- 6. Provide Legal Description of Property to Aid Researcher in Tracing Site's Legal Heritage
- 7. Establish Photographic Baseline (as of 2016) of Cemetery Conditions
- 8. Link Cemetery Description with Spreadsheet Listing Each Burial in That Cemetery

Maximize Value of Burial Information to Individual Family Researcher

- 1. Identify ALL known/alleged burials in each Cemetery Whatever the information source
 - Provide Individual Researcher with own copy of Listings and Photos No Need to Visit Actual Site
- 2. Enable Family Member to Make Additions/Corrections as Needed
 - Families will remain primary source of new information for these early burials
- 3. Maximize Ability to Transcribe Degraded Inscriptions by Manipulation of Hi-Res Digital Photo
- 4. Enable Convenient Sharing of Ancestral Information (e.g., Find-A-Grave.com) MS EXCEL Spreadsheet
- 5. Establish Photographic Baseline (as of 2016) for each Tombstone

I wanted to take the opportunity to express my personal thanks and appreciation to you and the Commissioners for the recent recognition of the work of the Friends of Two Rivers Mansion.
