CHAIR REPORT – Tyler Pittman

- Sheyla Paz has been re-confirmed for a 3 year term on the board
- PEG Studio aligning re-opening with NSCC timeline
- Expected re-opening planned for Mid-Late August
- Current cash balance is \$20,700 which puts us out to late September if no other money is received
- Board to propose any potential candidates to assist in grant writing or fund raising

NECAT Report – Cameron McCasland

- After meeting with NSCC member email to go out this week announcing scheduled timeline for studio to open and classes to restart
- Online training course completed on how to stay safe in studio and onset, shared on NECAT socials. Goal is to have all producers and technicians to follow protocols
- One year anniversary for Cam in the role at NECAT
- New path forward needed to facilitate educational programming with potential MNPS limitations for off site visits.
- Additional means to raise income needed.
