- NECAT Film Festival
 - 1) 55 entries airing over the past weekend

- 2) Sunday night showed the best of the weekend

- 5) Able to do 3-4 of these a year with themed events

Studio Manager Report - John Ferguson

- Board member involvement key factor in success of NECAT and happy to see contributions from all
- Still no plans to move into Phase IV until Spring of 2021 at NSCC
- Looking at allowing members to be able to check out equipment from Howard Building as opposed to the Courthouse now.
- Rough draft of policy document highlights rules/ costs presented for members to check out equipment. Paid memberships a pre-requisite to take advantage of this service & all funds go into NECAT's paypal account
- Hope to start rental program as soon as possible

Group Discussion

- Current revenue puts us at \$25K or five months if no new additional funding is secured
- Sources of new grants should be explored but we should also look at what channels can provide in the form of program sponsorship
 - 1) Repurposed content from large entities in exchange for sponsorship block on channels. Tractor Supply, MARS, Cracker Barrel, etc.
 - 2) Rate card needs to be put together that incorporates both existing and unique content opportunities for sponsorships in order to solicit support
 - Long term partnerships preferred for extended programming as opposed to one offs
 - 4) Music, cooking, exercise shows all potential opportunities for sponsored programming
 - 5) Feel Good Fridays tie in as well
- Chair Tyler Pittman's second full three year term is up at the end of January and will need to be replaced before next full slate election in June 2021
- Secretary position has been vacant since end of 2019 with Aqiyla Reed's departure from board with Tyler Pittman handling responsibilities
- Call for vote on filling Secretary position effective November 2020 and Chair elect effective February 2021
- Dana Shroering nominated for Secretary, Sheyla Paz nominated for Chair Elect
