### FRIENDS OF CROOKED BRANCH PARK PROVIDES THE BOARD AN UPDATE OF THEIR ORGANIZATION

The Friends of Crooked Branch Park appeared at the September Parks Board meeting to reach full recognition as a "Friends Group" of the Parks Department. An application for 501°(3) incorporation was presented along with list of board members and officers. However, not all the necessary requirements to be a Friends Group have been met.

Mr. Lynch stated that there have been many political issues created by past members of the board of this group that are problematic in receiving final approval from the Parks Board. The Parks Board policy which applies to Friends Groups was sent to this group for the second time so that they may understand that the sole intent and purpose of any Friends group is to work in conjunction with the Parks Board and Parks Department staff to enhance the park in area community and to augment park resources.

Mr. Lynch, as Director of Metro Parks, offered to host a meeting for the general public to attend where parks staff and other "Friend Groups" share their story in an effort for said group and the users of the park to understand what is and what is not acceptable from a recognized "Friends Group". There seems to be no clear understanding of this, since the Parks Department has been contacted by many individuals in the Crooked Branch Park area claiming that one group may be setting itself up to control the park from other interested users. That is simply not the intent of the Parks Board and should not be the intent of officers of any "Friends Group". A meeting is required before any formal recognition of a "Friends Group" can be obtained. Metro Parks intends to work with the entire community to form a relationship that can be sustained and prove beneficial to all concerned and any meeting for this purpose will be hosted by the Parks Department and the subject matter will consist solely of what other Friends Groups do and suggestions as to how group's efforts should be formulated.

### BOARD DENIES REQUEST OF MS. ANGELA DAVIS TO UTILIZE THE BLACK BOX <u>THEATRE IN THE CENTENNIAL ARTS ACTIVITY CENTER</u> ON A TEMPORARY BASIS FOR RELIGIOUS SERVICES

Ms. Driver requested that Park Policy 3000.2 be amended; however, Mr. George Anderson, Parks Board Chairperson, stated there would be no consideration given to changing said policy at the September 2<sup>nd</sup> board meeting as it did not appear on the board agenda and board would be in violation of policy.

#### BOARD DENIES REQUEST TO PLACE STATUE IN WALK OF FAME PARK

Mr. Frank Ortega was present to request board consideration to place a statue of Manuel, international clothier, in Walk of Fame Park.

Upon motion of Mr. Fossick, seconded by Ms. Smith, the board denied this request as it does not meet the requirements of park policy 3000.30 **Special Interest Memorials on Public Land**. Mr. Lynch suggested that this statue could possibly be placed on an area of sidewalk on Demonbreun Street adjacent to the Country Music Hall of Fame and if that suggestion was of interest to Mr. Ortega Mr. Lynch offered to assist in contacting the correct division of the Metropolitan Public Works Department.

Ms. Jen Cole, Director of the Metro Arts Commission, was present to request board approval of location of proposed public art for the West Bank Riverfront Park site.

### **BOARD APPROVES LOCATION OF PUBLIC ART** ON THE WEST BANK RIVERFRONT SITE

This presentation introducing the artist team, Laura Haddad and Tom Drugan of Seattle, Washington, who has been commissioned for a large-scale artwork at the West Riverfront Park site, also showcased the "River Concept" sculpture at the entry of the park. The form of this sculpture based upon the Cumberland River and its winding through Nashville and Davidson County symbolizing a reconnection to the river was very ingenious.

### BOARD GRANTS APPROVAL OF APPLICATION AND ULTIMATE ACCEPTANCE OF A MINI-GRANT FROM THE METRO ARTS COMMISSION FOR USE IN THE REGIONAL CENTERS

Upon motion of Mr. Fossick, seconded by Ms. Smith, the board granted approval of application and ultimate acceptance of a \$900.00 mini-grant from the Metro Arts Commission to provide art instruction during after school programming in six (6) Metro Parks Regional Recreation Centers.

Funding will be used to pay fee for one teaching artist. Tim Olliphant, "Mr. Ollie", is on the Tennessee Arts Commission Teaching Roster and Mr. Ollie will teach students how to create their own cartoon characters using geometric shapes. This method is easy to understand and follow and the students will not only learn about drawing and techniques, but about how and why certain things in nature look.

### **BOARD APPROVES ACQUISITION OF 13 ACRES AS AN ADDITION TO BEAMAN PARK**

Upon motion of Mr. Fossick, seconded by Ms. Garcia, the board approved acquisition of 13 acres on Blueberry Hill Road as an addition to Beaman Park.

Acquisition of 13 acres from a tract of land at 4207 Blueberry hill Road, map 038000126, from the Tennessee Parks and Greenways Foundation (TPGF) for addition to Beaman Parks, using \$25,000 in existing funds. The purchase will be at half the acquisition cost of the 13 acres by TPGF, which purchased the property for \$50,000 in May 2014. TPGF's market analysis of comparable sales was \$4,667.35 per acre and TGPF paid \$3,846 per acre. Conservation of the property is consistent with the Parks and Greenways Master plan and will provide additional buffer for Beaman Park as well as open space conservation.

### BOARD GRANTS APPROVAL FOR METRO PARKS TO PROVIDE MATCHING GRANTS FOR THE DEVELOPMENT, OPERATION AND MAINTENANCE OF COMMUNITY GARDENS

Upon motion of Ms. Smith, seconded by Ms. Garcia, the board granted approval for Metro Parks to provide matching grants to eligible nonprofit organizations to develop, operate, and/or maintain community gardens in Nashville/Davidson County within the area of the metropolitan government for the use and benefit of the community and/or schools.

Community Gardens provide innumerable benefits to neighborhoods and communities. They are catalysts for producing healthy foods, reducing grocery budgets, encouraging social interaction, reducing crime and stimulating neighborhood development. In addition, they filter rainwater, reduce air pollution and add purpose and beauty to greenspace.

Only nonprofit organizations can submit applications. Other requirements include:

- Organizations must be currently registered with the Tennessee Secretary of State Office to do business in Tennessee, and have filed the necessary report to the Secretary of State's Office of Charitable Solicitation (unless, according to the organization's size, it does not meet the threshold requirement).
- Grant funds awarded under the program must be used at school or community gardens for the benefit of children and/or senior citizens with an emphasis on contributing to healthy lifestyles/eating, addressing childhood obesity, eliminating food deserts, and/or promoting sustainable food sources.
- Grant funds may be used for programming or supplies for the school/community garden.

Live on the Green is wrapping up for the season and has averaged 15,000 weekly.

Opening of the Peeler Park Greenway Trail at Taylor Farm is scheduled for Saturday, September 13<sup>th</sup>.

Shakespeare in the Park's final performance is scheduled for Sunday, September 14<sup>th</sup>.

Tennessee Craft Artists Fall Fair is scheduled for Friday, September 26, Saturday, September 27 and Sunday, September 28, 2014.
